PART III (INNER CITY)

The Birmingham City Council (Off-Street Parking Places) (Amendment) (No.1) Order 1998 – Part III (Inner City)

The Birmingham City Council in exercise of their powers contained in Section 35(1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to this Act and of all other enabling powers, and after consultation with the Chief Officer of Police of the West Midlands in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order.

- 1. The City of Birmingham District Council (Off-Street Parking Places) Order 1986 Part III (Inner City) shall have effect subject to the amendments specified in the Schedule to this Order.
- 2. This Order may be cited as the Birmingham City Council (Off-Street Parking Places) (Amendment) (No.1) Order 1998 Part III (Inner City) and shall come into operation on the 11th day of May 1998.

SCHEDULE

In Article 7(b) of the Order the words "paragraph (1)" shall be deleted and the words "paragraph (a)" shall be substituted.

In Article 9 of the Order the words "paragraph (b)" shall be deleted and the words "paragraph (c)" shall be substituted.

In Article 24 of the Order the words "Article 25" and "Articles 26 or 27" shall be deleted and the words "Article 21" and "Articles 22 or 23" shall be substituted respectively.

In Article 25 of the Order the words "Articles 26 or 27" shall be deleted and the words "Articles 22 or 23" shall be substituted therefor.

PART I

Part I of the Schedule to the Order shall be amended in respect of Irving Street as follows:

Column 4: The days of operation of the car park shall be deleted and the following days shall be substituted:

"Monday to Saturday Inclusive, Excluding Bank Holidays and Christmas Day"

Column 5: The hours of operation of the parking place shall be deleted and the following hours shall be substituted:

"0800 to 2200 hours"

Column 6: The maximum periods for which vehicles may wait shall be deleted and the following period shall be substituted:

"14 hours"
