The Birmingham City Council (Off-Street Parking Places) (Amendment) (No.1) Order 1999 – Part III (Inner City)

The Birmingham City Council in exercise of their powers contained in Section 35(1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to this Act and of all other enabling powers, and after consultation with the Chief Officer of Police of the West Midlands in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order.

- 1. The City of Birmingham District Council (Off-Street Parking Places) Order 1986 Part III (Inner City) shall have effect subject to the amendments specified in the Schedule to this Order.
- 2. This Order may be cited as the Birmingham City Council (Off-Street Parking Places) (Amendment) (No.1) Order 1999 Part III (Inner City) and shall come into operation on the 1st day of April 1999.
