**Order 2001 – Part VI (North)**

The Birmingham City Council in exercise of the powers contained in Section 35(1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to this Act and of all other enabling powers, and after consultation with the Chief Officer of Police of the West Midlands in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order.

**1. Citation and Commencement**

This Order may be cited as the Birmingham City Council (Off-Street Parking Places) (Amendment) (No.1) Order 2001 – Part VI (North) and shall come into operation on the 1st day of April 2001.

**2. Interpretation**

- (1) In this Order "the Order" means the City of Birmingham District Council (Off-Street Parking Places) Order 1986 - Part VI (North);
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted or as having effect by virtue of any subsequent enactment;
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the Order shall have the same meaning as in the Order.

**2. Amendment of the Order**

Without Prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order shall have effect as though:-

- a) The scale of initial charges enumerated in Part II of the Schedule to the Order shall be deleted and the following scale of charges substituted:

**Barr Street, Boulton Road, Buckingham Street, Elkington Street, Hanley Street/Cecil Street, Hanley Street/Summer Lane, Hampton Street/Mott Street, Hockley Flyover, Northwood Street, St Helens Passage, Smith Street, The Crescent, Hockley, Ward Street, Waverhill Road, Handsworth and Witton Road/Manor Road**
