### **ORDER 2001**

Birmingham City Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

- 1. This Order shall come into operation on the 23rd day of March Two Thousand and One and may be cited as "Birmingham City Council (Jewellery Quarter Birmingham) (Controlled Zone) (Variation) (No. 8) Order 2001".
- 2. (1) In this Order:
  - (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
  - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The Birmingham City Council (Jewellery Quarter Birmingham) (Controlled Zone) Order 1992 shall continue in full force and effect subject to the variations described in the Schedule of this Order.

#### **SCHEDULE 2**

In the reference to parking place No. 32 the figure "62" in column 2 and the figure "61" in column 3 shall be deleted and the figures "6" and "5" shall be substituted therefor.

Following the reference to parking place No. 32 there shall be inserted the following new reference:

- All that part of the south east side of HOCKLEY STREET
  which is bounded on the south east by so much of the
  edge of the carriageway of that highway as extends from
  a point 46 metres north east of the north east kerbline
  of Branston Street for a distance of 16 metres and which
  has a width throughout of 2 metres.

## **SCHEDULE 3**

In the first reference to Hockley Street, south east side, the figure "15" shall be deleted and the figure "24" shall be substituted therefor.

Following the first reference to Hockley Street, south east side, the following new reference shall be inserted:

From a point 16 metres north east of the north east kerbline of Branston Street for a distance of 30 metres in a north easterly direction.
