BIRMINGHAM CITY COUNCIL (JEWELLERY QUARTER BIRMINGHAM) (CONTROLLED ZONE) (VARIATION) (NO. 3) ORDER 1997

The Birmingham City Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

- 1. The Order shall come into operation on the 31st day of March one thousand nine hundred and ninety-seven and may be cited as Birmingham City Council (Jewellery Quarter Birmingham) (Controlled Zone) (Variation) (No. 3) Order 1997.
- 2. (i) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The Birmingham City Council (Jewellery Quarter Birmingham) (Controlled Zone) Order 1992 as amended shall continue in full force and effect subject to the variations specified in the Schedule to this Order.

SCHEDULE

<u>Variations of The Birmingham City Council (Jewellery Quarter Birmingham)</u> (Controlled Zone) Order 1992

In Article 2(1) of the Order the definition of a "parking meter" shall be deleted and the following definition shall be substituted:

"parking meter" means apparatus designed to indicate the time by a clock and to issue a numbered parking ticket indicating the payment of a charge, the period in respect of which it has been paid and the date and time at which the charge was paid."

In Article 7 sub-article "1(c)" and "1(d)" shall be deleted and the following sub-articles shall be substituted:

- "(1) (c) one pound and ten new pence (£1.10p) for an initial period of not more than 3 hours; and
 - (d) one pound and fifty new pence (£1.50p) for an initial period of not more than four hours."

In Article 12 sub-article "(1)(c)", "(1)(d)" and "(2)" shall be deleted and the following sub-articles shall be substituted:

- "(1) (c) where it is an amount of One Pound and ten new pence (£1.10p) by the issue by the parking meter relating to the parking place in which the vehicle is left of a ticket indicating that the charge has been paid in respect of three hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of the said Article 7(3); and
 - (d) where it is an amount of One Pound fifty new pence (£1.50p) by the issue by the parking meter relating to the parking place in which the vehicle is left of a ticket indicating that the charge has been paid in respect of four hours and the day and time of payment of the charge, and by the display of that ticket on the vehicle in accordance with the provisions of the said Article 7(3)."



2. The expiry of the initial period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket issued by the parking meter relating to the parking space in which the vehicle is left showing the day and time of payment of the charge and the time shown by the clock on the said parking meter is more than one hour, or, as the case may be, two hours, three hours or four hours later than the time shown on a ticket issued in respect of a payment of thirty new pence (30p) or more than two hours, or, as the case may be, three hours or four hours later than the time shown on a ticket issued in respect of a payment of sixty new pence (60p), or more than three hours later, or as the case may be, four hours later than the time shown on a ticket issued in respect of a payment of One Pound and ten new pence (£1.10p) or more than four hours later than the time shown on a ticket issued in respect of a payment of One Pound fifty new pence (£1.50p).
