

BIRMINGHAM CITY COUNCIL
(JEWELLERY QUARTER BIRMINGHAM)
(CONTROLLED ZONE) (VARIATION) ORDER 1994

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 49, 53, 101, and 102 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

1. This Order shall come into operation on the 19th day of June One thousand nine hundred and ninety four and may be cited as "Birmingham City Council (Jewellery Quarter Birmingham) (Controlled Zone) (Variation) Order 1994".
2. In this Order:
 - (1) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The Traffic Regulation Orders specified in the Schedule to this Order shall continue in full force and effect subject to the variations described therein.

The second reference to Great Hampton Street shall be deleted from the Schedule and the following references substituted therefor

"GREAT HAMPTON STREET

northeast side, from the line of the kerb on the southeast side of Well Street for a distance of 41.7 metres in a southeasterly direction

southwest side, from the line of the kerb on the southeast side of Vyse Street for a distance 29.4 metres in a southeasterly direction"
