BIRMINGHAM CITY COUNCIL (NEW TOWN ROW ETC, BIRMINGHAM)(TRAFFIC REGULATION) ORDER 1997

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

- 1. This Order shall come into operation on the 17th day of January One thousand nine hundred and ninety seven and may be cited as "Birmingham City Council (Newtown Row etc Birmingham) (Traffic Regulation)) Order 1997".
- 2. (1) In this Order:

"authorised cab rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Schedule 6 to The Traffic Signs Regulations and General Directions 1994;

"authorised parking place" means any parking place on a road authorised or designated by an Order made or having effect as if made under the Act of 1984;

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982;

"disabled person's vehicle" has the same meaning as in The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1991;

"hackney carriage" means a licensed taxi as defined in Section 13(3) of the Transport Act 1985.

"parking disc" means a disc, issued by a local authority, 125 millimetres square, coloured orange, and capable of showing the quarter hour period during which a period of waiting began.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying:
- (a) a disabled persons badge in the relevant position if:
- (i) in the case of a vehicle fitted with a dashboard or Facia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle: or
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle.
- (b) a parking disc in the relevant position if:

- (1) (a) a person to board or alight from the vehicle:
 - (b) the vehicle if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations:
 - (ii) the removal of any obstruction to traffic:

(iii)the maintenance, improvement or reconstruction of the said lengths of road or sides of road: or

- (iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of road or sides of rad or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984:
- (c) the vehicle if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority, a water undertaker or a sewerage undertaker or the National Rivers authority in pursuance of statutory powers or duties;
- (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953:
- (e) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of road so long as the waiting by that vehicle is reasonably necessary in connection with any wedding or funeral: or
- (f) the vehicle to be used for fire brigade, ambulance or police purposes.
- Nothing in Articles 3, 4, 5 and 6 shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle.
 - (a) in the lengths of road specified in Articles 3.4 and 5 of this Order at any time on any day: or
 - (b) in the lengths of road specified in the Article 6 to this Order at any time except between the hours of 7.00 am and 10.00 am or between the hours of 4.00 pm and 7.00 pm on any day other than Saturday and Sunday.
- (3) Nothing in Article 3 shall render it unlawful to cause or permit any vehicle
 - (a) to wait upon an authorised parking place, or
 - (b) being a licensed taxi, to wait upon an authorised cab rank.

BIRCHFIELD ROAD

West side from its junction with High Street to the line of the kerb on the south side of Johnstone Street.

West side from a point approximately 110 metres south of the line of the kerb on the south side of Heathfield Road to a point approximately 195 metres north of the line of the kerb on the north side of Heathfield Road.

West side from the line of the kerb on the south side of Willmore Road to its junction with Aldridge Road.

East side from its junction with Aldridge Road to the line of the kerb on the south side of Bragg Road.

East side from a point approximately 250 metres south of the line of the kerb on the south side of Canterbury Road to a point approximately 90 meters south of the line of the kerb on the south side of Trinity Road.

East side from a point approximately 230 meters south of the line of the kerb on the south side of Arden Road to a point approximately 80 meters south of the line of the kerb on the south side of Mansfield Road.

East side from a point approximately 147 meters south of the line of the kerb on the south side of Mansfield Road to its junction with High Street.

HIGH STREET

Both sides from its junction with Birchfield Road to its junction with New Town Row.

HOLFORD DRIVE

North side, from the east kerb line of Aldridge Road for a distance of 14 metres in an easterly direction.

North side, from a point 83 metres east of the east kerb line of Aldridge Road for a distance of 11 metres in an easterly direction.

South side from the line of the kerb on the east side of Aldridge Road for a distance of approximately 10 metres in an easterly direction.

South side from a point approximately 83 metres east of the line of the kerb on the east side of Aldridge Road for a distance of approximately 20 metres in an easterly direction.

NEW TOWN ROW

/East side from the line of the kerb on the north side of Pritchett Street to a point approximately 10 metres south of the line of the kerb on the south side of Pritchett Street.

East side from a point approximately 35 metres south of the line of the kerb on the south side of Pritchett Street for a distance of approximately 40 metres in a southerly direction.

THIRD SCHEDULE (ARTICLES 5)

Waiting Limited To One Hour Return Prohibited Within One Hour Between The Hours of 7.00 am And 7.00 pm Monday To Saturday Inclusive

ALDRIDGE ROAD

East side from a point approximately 66 metres north of the line of the kerb on the south side of Church Road for a distance of approximately 44 metres in a southerly direction.

BIRCHFIELD ROAD

East side from a point approximately 20 metres of the line of the kerb on the south side of Bragg Road for a distance of approximately 43 metres in a southerly direction.

East side from a point approximately 80 metres south of the line of the kerb on the south side of Mansfield Road for a distance of approximately 67 metres in a southerly direction.

NEW TOWN ROW

East side from a point approximately 10 metres south of the line of the kerb on the south side of Pritchett Street for a distance of approximately 25 metres in a southerly direction.

FOURTH SCHEDULE (ARTICLE 6)

No Loading/Unloading Between The Hours Of 7.00 am to 10.00 am and 4.00 pm and to 7.00 pm

BRICHFIELD ROAD

West side from its junction with High Street to its junction with Aldridge Road.

East side from its junction with Aldridge Road to a point approximately 20 metres south of the line of the kerb on the south side of Bragg Road.

East side from a point approximately 15 metres north of the line of the kerb on the north side of The Broadway to a point approximately 80 metres south of the line of the kerb on the south side of Mansfield Road.

East side for a point approximately 147 metres south of the line of the kerb on the south side of Mansfield Road to its junction with High Street.
