**ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65  
AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS**

The Secretary of State for Transport, in exercise of powers conferred on her by Sections 64(1) and (2) and 65(1) of the Road Traffic Regulation Act 1984<sup>(1)</sup> and of all other powers enabling her in that behalf, hereby gives the authorisation contained in paragraphs 2 and 3 of this Instrument and gives the directions contained in paragraph 4 of this Instrument.

**1. In this Instrument:-**

"authorised sign" means a traffic sign whose erection is authorised by paragraph 2(1)(a);

"authorised marking" means a road marking whose placing is authorised by paragraph 2(1)(b);

"red route controls" means prohibitions or restrictions imposed by or under an order or notice under the Road Traffic Regulation Act 1984 on any class of traffic on an A or B class classified road in the West Midlands, or a road which is a slip road to such a road.

**2. (1) Subject to paragraph 3 below, the Secretary of State hereby authorises:-**

(a) the bus parking sign as shown in drawing GT50190/0002-1; and

(b) the bus parking marking as shown in drawing GT50/190/0002-2;

for the purpose of conveying to traffic the effect of red route controls applying to that road.

(2) Where it is specified in a drawing that part of a sign or marking is to be of a particular colour, the colour of that part shall be as shown in the notes to the appropriate sign drawing.

3. (1) The provisions of Regulation 12(10) (variation of dimensions) of The Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations") shall apply to the dimensions specified in the said set of drawings in relation to the authorised signs or authorised markings as they apply to dimensions specified in those Regulations.

(2) The provisions of Regulations 18 and 19 of the 2002 Regulations (illumination of signs) shall apply to the authorised signs as they apply to the sign shown in diagram 650.1 in Schedule 5 to those Regulations.

(3) No authorised marking shall project above the surface of the adjacent carriageway more than 6 millimetres at any point.

(4) Any indication given by an authorised sign or marking of a time of day, day of the week or class of traffic may be varied so as to correspond with the red route controls whose effect the sign or marking has been placed to indicate.

(5) Where: a) overall dimensions are given for an authorised sign or marking in a drawing in the said set of drawings;

b) and the legend on that sign or marking is varied in accordance with sub-paragraph (4) above,

the overall dimensions or the number of lines occupied by the legend, or both, may be varied so far as necessary to give effect to the variation of the legend.

4. The Secretary of State hereby directs that:-

(1) notwithstanding any previous direction an authorised double red line marking as shown in diagram B1 on drawing GT50/190/0001-1 page WMRR1-01 may be placed on the highway without being in conjunction with any traffic sign; and

(2) without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs and placing of the authorised markings at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised signs and placing of the authorised markings authorisation shall, without prejudice to the giving of any further authorisation or direction and on that day the said, cease to have effect.

This authorisation is in addition to the earlier one dated 9 May 2012 under reference GT50/190/0001.

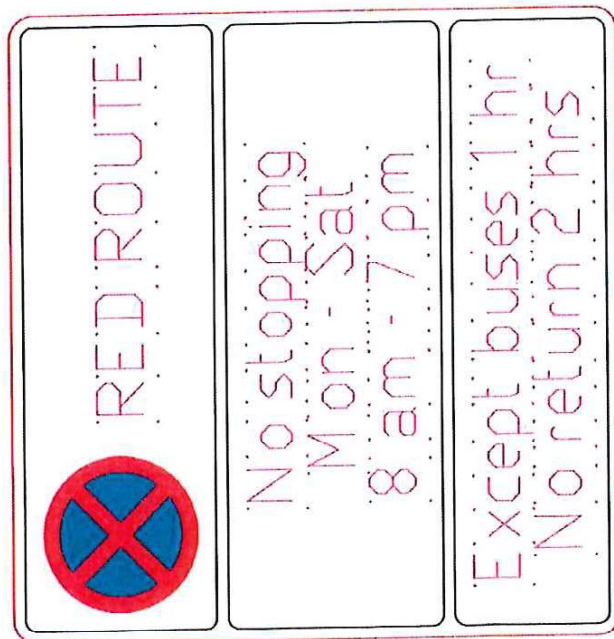

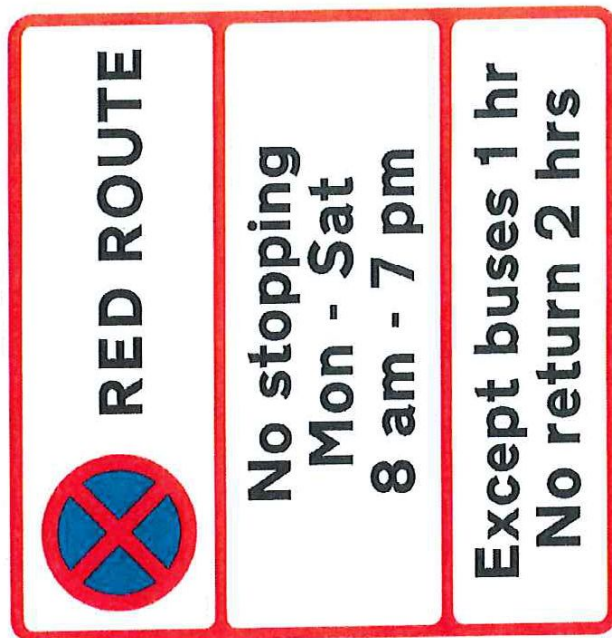
