

BIRMINGHAM CITY COUNCIL
(RESERVED BUS LANES AND BUS ONLY ROADS ETC)
(VARIOUS ROADS BIRMINGHAM)
(ORDER 2013) (VARIATION) (No 3) ORDER 2015

Birmingham City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order,

1. The "Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads, Birmingham) Order 2013" (as amended) shall continue in full force and effect subject to the variation specified in the SCHEDULE to this Order.
2. This Order shall come into operation on the 20th day of November Two thousand and fifteen and may be cited as "Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads, Birmingham) (Order 2013) (Variation) (No 3) Order 2015".

SCHEDULE

Variation to Birmingham City Council (Reserved Bus Lanes and Bus Only Roads Etc) (Various Roads, Birmingham) Order 2013,

1. In Schedule 1 after the reference to "Hagley Road" the following reference shall be inserted.

2. In Schedule 1 in the reference to LONGMORE STREET shall be deleted and replaced with

LONGMORE STREET	Any area of the north east bound carriageway (except the left turn slip road) from a point approximately 37 metres from the southern extended kerb line of Belgrave Middleway	for a distance of approximately 26 metres in a north easterly direction	All days all times	Bus, Licensed Taxi, Pedal Cycle

3. In Schedule 2 in the reference to HORTON SQUARE in column (2) the words "northeast bound carriageway" shall be deleted and replaced with "south west bound carriageway".
4. In Schedule 2 after the words "HAGLEY ROAD" in column (1) the word "WEST" shall be inserted.
