# THE BOROUGH OF BLACKBURN WITH DARWEN (VARIOUS DARWEN TOWN CENTRE STREETS) (WAITING AND LOADING RESTRICTIONS) (EXPERIMENTAL) (AMENDMENT) ORDER 2018

Blackburn with Darwen Borough Council, in exercise of the powers of the said Council under Section 9 and 10 of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:-

## CITATION AND COMMENCEMENT

1. This Order shall come into operation on the day of May 2018 and may be cited as the Borough of Blackburn with Darwen (Various Darwen Town Centre Streets) (Waiting and Loading Restrictions) (Experimental) (Amendment) Order 2018

#### INTERPRETATION

- 2. In this Order -
  - (1) "the Order of 2017" means the Borough of Blackburn with Darwen (Various Darwen Town Centre Streets) (Waiting and Loading Restrictions) (Experimental) ) Order 2017;
  - (2) the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and
  - (3) any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

### **AMENDMENT TO THE ORDER OF 2017**


- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before coming into force of this Order, the Order of 2017 shall have effect as though:
  - (1) Schedule 4 of the Order of 2017 is removed and substituted with the Schedule 4 within this Order.
  - (2) A new Schedule 6 as contained within this Order shall be added to the Order of 2017;
  - (3) The following new Article 11 shall be inserted into the Order of 2017:
    - 11. Save as provided in Articles 7.1, 7.2, 7.3, 7.4, 7.5 and 8 of the provisions of this Order no person shall, except on the direction of or with the permission of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm on any day other than a Sunday on the sides of road or in any of the length of road specified in Schedule 6 other than a vehicle engaged in the provision of a local service as defined in Section 2 of the Transport Act 1985:-
      - (a) for a longer period than 2 hours; or

		for a distance of 20 metres in a southerly direction
Railway Road	North West	From a point 52 metres north east of the easterly kerbline of Parliament Street for a distance of 47 metres in a north easterly direction
Church Street,		From a point 70 metres north east of the northerly kerbline of Bridge Street for a distance of 12 metres in a north easterly direction
