## COUNTY BOROUGH OF BLACKBURN

(MARKET STREET LANE) (NO WAITING) ORDER, 1970.

THE BLACKBURN COUNTY BOROUGH COUNCIL in exercise of their powers under Section 1 of the Hoad Traffic Regulation Act 1967 and of all other powers them enabling HEREBY MAKE the following Order:-

- 1. Save as provided in Articles 3 and 4 hereof no persons shall cause or permit any vehicle to wait at any time in the lengths of street specified in the First Schedule hereto, except upon the direction or with the permission of a police officer in uniform.
- 2. Save as provided in Articles 3 and 4 hereof no person shall cause or permit any vehicle to wait between the hours of 7. a.m. and 7. p.m. on any day of the week except Sunday for more than one hour in any period of two hours in the lengths of street specified in the Second Schedule hereto, except upon the direction or with the permission of a police officer in uniform.
- 3. Nothing in Article 1 hereof shall prevent any person from causing or permitting a vehicle to wait in the lengths of street specified in the Schedule hereto for so long as may be necessary:
  - (a) to enable a person to board or alight from the vehicle;
  - (b) to enable goods to be loaded on to or unloaded from the vehicle; or
  - (c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other street, to be used in connection with any building operation or demolition funeral, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the lengths of street so referred to or the laying, erection, alteration or repair in or near to the said lengths of street of any sewer or of any main, pipe, or apparatus for the supply of electricity, water or was, or of any telegraphic line as defined in the Telegraph Act 1878;
  - (4) to mable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of street.

- 5. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations and, or leving effect as if made, under the Road Traffic Act 1960 or the Road Traffic Regulation Act 1967 or by or under any other enactment.
- t. The Interpretation Act 1839 shall apply for the interpretation of this Trick as it applies for the interpretation of an Act of Parliament.
- 7. This rader shall come into operation on the 50th day of April 1970 and as a diller as the "County Borough of Blackburn (Larket Street Lane) (No Jaiting) form 1976".

Street	Side	Length
Market St. Lane	South	From a point 17 yards west of Darwen Street to a point 37 yards west of Darwen Street
Market St. Lane	South	From a point 22 yards east of Mincing Lane to a point 39 yards east of Mincing Lane
