THE BOROUGH OF BLACKBURN WITH DARWEN (SCHOOL ENTRANCE CLEARWAY) (VARIATION) ORDER 2019

The Blackburn with Darwen Borough Council, in exercise of the powers of the said Council under Sections 1, 2, 4 and 124 of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:-

- 1. This Order shall come into operation on the 29th November 2019 and may be cited as the Borough of Blackburn with Darwen (School Entrance Clearway) (Variation) Order 2019.
- 2. In this Order "School Entrance Markings" means any area of carriageway in any of the lengths of road or on the sides of road specified in the Schedules to this Order intended for the entrance to School premises which is comprised within and indicated by a road marking complying with diagram 1027.1 in Schedule 6 to the Traffic Signs Regulations and General Directions 1994.
- 3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 4. Save as provided in Articles 7 and 8 no person shall, except upon the direction with the permission of a police officer or traffic warden, cause or permit any vehicle to stop, at any time, in the area marked as a School Entrance on the lengths of road specified in Schedule 1 to this Order.
- 5. Save as provided in Articles 7 and 8, no person shall, except upon the direction with the permission of a police officer or traffic warden, cause or permit any vehicle to stop, between the hours of 8.00 a.m. 5.00 p.m. on any day except Saturday and Sunday, in the area marked as a School Entrance on the length of road specified in Schedule 2 to this Order.
- Save as provided in Articles 7 and 8, no person shall, except upon the direction with the permission of a police officer or traffic warden, cause or permit any vehicle to stop, between the hours of 8.00 a.m. 4.00 p.m. on any day except Saturday and Sunday, in the area marked as a School Entrance on the length of road specified in Schedule 3 to this Order.
- 6. Nothing in Article 4, 5 or 6 of this Order shall apply as to prevent a vehicle from stopping in the length of road specified in the Schedule to this Order, when the person in control of the vehicle
 - (i) is required by law to stop;
 - (ii) is obliged to stop in order to avoid an accident, or
 - (iii) is prevented from proceeding by circumstances outside his control.
- 7. Nothing in Article 4, 5 or 6 shall render it unlawful to cause or permit any vehicle to wait in the length of road referred to therein if it cannot be conveniently used for such purpose in any other road, to be used in connection with any of the following operations, namely -
 - (i) building maintenance industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - the maintenance, improvement or reconstruction of the said lengths of road or side of road;
 - (iv) the laying, creetion, alteration or repair in or in land adjacent to the said lengths of road or side of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in paragraph 1(i) of the Telecommunications Code contained in Schedule 2 to the Telecommunications Act 1984;
 - (v) the vehicle if cannot conveniently be used for such purpose in any other road, to be

used in the service of a local authority in pursuance of statutory powers or duties; or

- (vi) the vehicle to be used for fire brigade, ambulance or police purposes.
- 8. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 9. The Orders specified in Schedule 4 of this Order are hereby revoked to the extent specified in the description thereof
