

BLACKPOOL BOROUGH COUNCIL
THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS
RESTRICTIONS) AND (REVOCATION) VARIATION ORDER 2003

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2(1) to 3, 3(2), 4 and 124(1)(d) of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as the "Act of 1984") and the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 and of all other enabling powers and after consultation with the Chief Officer or Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:-

1. Article 1 of The Borough of Blackpool (Various Roads) (Various Restrictions) and (Revocation) No 3 Order 2003 (hereinafter referred to as "the Order") shall be varied as follows:
 - (a) by substitution of 'Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003' for 'Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, One Way Traffic, Prohibition of Through Traffic, Pedestrian Areas, Weight Restrictions, Width Restrictions and Protection of Bus Stops) Order 2000' and
 - (b) by substitution of "the said Order of 2003" for all references throughout the said Article 1 to "the said Order of 2000" and
 - (c) by substitution of "Article 13" for "Article 32" and
 - (d) by substitution of "Article 12" for "Article 31" and
 - (e) by substitution of "Article 11" for "Article 10".
2. Article 2 of the Order shall be varied by substitution of 'Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003' for 'Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, One Way Traffic, Prohibition of Through Traffic, Pedestrian Areas, Weight Restrictions, Width Restrictions and Protection of Bus Stops) Order 2000'.
3. Article 3 of the Order shall be varied by substitution of 'Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003' for "Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, One Way Traffic, Prohibition of Through Traffic, Pedestrian Areas, Weight Restrictions, Width Restrictions and Protection of Bus Stops) Order 2000'.
4. Article 4 of the Order shall be varied by the substitution of the "said Order of 2003" for the "said Order of 2000"

5. Article 5 of the Order shall be varied by the substitution of the "said Order of 2003" for "the said Order of 2000".
6. This Order shall come into operation on the 10th November 2003 and may be cited as The Borough of Blackpool (Various Roads) (Various Restrictions) and (Revocation) Variation Order 2003.
