BLACKPOOL BOROUGH COUNCIL THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) NO 3 ORDER 2004

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument 2677) and of all other enabling powers hereby make the following Order:-

<u>1. THE</u> Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part I of the Second Schedule to the said Order of 2003.

<u>2. THE</u> Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the following provisions contained in the Second Schedule to this Order were contained in and formed part of the Sixteenth Schedule to the said Order of 2003 as inserted by The Borough of Blackpool (Various Roads) (Various Restrictions) N° 5 Order 2003.

<u>3. THE</u> said Order of 2003 shall be in full force and effect as if the above provisions had originally formed part thereof.

<u>4. ANY</u> provisions contained in the said Order of 2003 and inconsistent with the provisions of this Order are hereby revoked.

<u>5. THIS</u> Order shall come into operation on the 12th day of July 2004 and may be cited as "THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) NO 3 ORDER 2004".

No Waiting At Any Time

Deneway Avenue - From Newton Drive for a distance of 10m in a Northerly direction - Both Sides

Newton Drive - From a point 49m west of Deneway Avenue to a point 54m east of Deneway Avenue - North Side

Newton Drive - From a point 33m east of Deneway Avenue for a distance of 106m in a westerly direction - South Side

Preston Old Road - From a point 7m east and west of the junction with Rosefinch Way and Cornwall Place - Both Sides

Preston Old Road/Cornwall Place - From the boundary of Nos 268/270 Preston Old Road to the most easterly boundary of No 7 Cornwall Place a distance of 36m north - Both Sides

Preston Old Road/Cornwall Place - From a point 9m east and west of the junction with Suffolk Road and Preston Old Road to the boundaries of Nos 1-4 Suffolk Road - Both Sides

Preston Old Road/Birch Tree Gardens - From the junction of Birch Tree Gardens with Preston Old Road to a point 7m east - Both Sides

Whinney Heys Road - From a point 6m south of Whinpark Avenue for a distance of 25m in a southerly direction - West Side for three vehicles

Whinpark Avenue - From a point 40m east of East Park Drive for a distance of 12m in an easterly direction - South Side for two vehicles
