# BLACKPOOL BOROUGH COUNCIL THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (PROHIBITION OF WAITING) AND (REVOCATION) NO 4 ORDER 2004

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2(1) to (3), 4(2) and 124 of Part IV of Schedule 9 o of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

<u>1. THE</u> Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part I of the Second Schedule to the said Order of 2003.

<u>2. THE NO WAITING</u> provisions contained in Part I of the Second Schedule of the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places Residents' Parking Places and Protection of Bus Stops) Order 2003 are revoked so far as the lengths of road referred to in the Second Schedule to this Order are concerned.

<u>2. THE</u> said Order of 2003 shall be in full force and effect as if the above provisions had originally formed part thereof.

<u>3. ANY</u> provisions contained in the said Order of 2003 and inconsistent with the provisions of this Order are hereby revoked.

<u>4. THIS</u> Order shall come into operation on the 4th day of April 2005 and may be cited as "THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (PROHIBITION OF WAITING) AND (REVOCATION) NO 4 ORDER 2004".

# **FIRST SCHEDULE**

# NO WAITING AT ANY TIME

FLEETWOOD ROAD, From College Avenue to Queens Promenade, West side

QUEENS PROMENADE, From a point 11m south of Maida Vale to Fleetwood Road, West side

QUEENS PROMENADE, From Fleetwood Road to a point 14m south of Maida Vale, East side.

MAIDA VALE, From Queens Promenade for a distance of 5m in an easterly direction – Both sides.

FLEETWOOD ROAD, From Queens Promenade for a distance of 30m in an easterly direction, South side.

FLEETWOOD ROAD, From Kelso Avenue to a point 14m East of Gresham Road, North Side

GRESHAM ROAD, From Fleetwood Road for a distance of 5m in a Northerly direction, Both sides

KELSO AVENUE, From Fleetwood Road for a distance of 45m in a northerly direction, East side

FLEETWOOD ROAD, From a point 10m north of Rookwood Avenue to a point 113m south of Rookwood Avenue, East side

FLEETWOOD ROAD From a point 10 north of Jem gate to a point 25m south of Norbreck Road, West side

ROOKWOOD AVENUE, From Fleetwood Road for a distance of 10m in an easterly direction, Both sides

JEM GATE, From Fleetwood Road for a distance of 10m in a westerly direction, Both sides

NORBRECK ROAD, From Fleetwood Road for a distance of 10m in a westerly direction, Both sides

BRANSTREE ROAD, From a point 10m west of Bowness Avenue to a point 10m east of Bowness Avenue, Both sides

BOWNESS AVENUE, From a point 15m North of Branstree Road to a point 235m in a southerly/easterly/northerly direction, West/South/East sides.

# SECOND SCHEDULE

# **REVOCATION OF NO WAITING AT ANY TIME**

BRANSTREE ROAD, From a point 10m west of Branstree Road to a point 10m east of Branstree Road, Both sides.

BRANSTREE ROAD, From a point 15m North of Branstree Road to a point 235m in a southerly/ westerly/northerly direction, West/South/East sides.
