BLACKPOOL BOROUGH COUNCIL THE BOROUGH OF BLACKPOOL (VARIOUS RESIDENT'S PARKING SCHEMES) VARIATION ORDER 2004

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Section 1, 2, 4, 45,46, 46A, 49, 53, 124(1)(d) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as the "Act of 1984") and after consultation with the Chief Officer or Police in accordance with Part III of Schedule 9 to the Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

1. THE Borough of Blackpool (Consolidation of Waiting Restrictions, On Street Parking, Residents' Parking Places, and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of the Fifth Schedule to the said Order of 2003 under the existing heading as indicated in the said First Schedule; the provisions contained in the Second Schedule to this Order were contained in and formed part of Part I of the Second Schedule to the said Order of 2003; the provisions contained in the Third Schedule to this Order were contained in and formed part of the Sixth Schedule to the said Order of 2003 under Ibbison Court/Kent Road

2. THE NO WAITING restrictions contained in Part I of the Second Schedule of the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, and Protection of Bus Stops) Order 2003 are revoked so far as the lengths of road referred to in the Fourth and Fifth Schedules to this Order are concerned.

<u>3. THE</u> Areas on Highways (or Parts) of Highways Designated as Parking Places with Permits contained in the Fifth Schedule of the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, and Protection of Bus Stops) Order 2003 are revoked so far as the lengths of road referred to in the Sixth Schedule to this Order are concerned.

<u>4. THE</u> said Order of 2003 shall be in full force and effect as if the above provisions had originally formed part thereof.

5. ANY provisions contained in the said Order of 2003 and inconsistent with the provisions of this Order are hereby revoked.

6. THIS Order shall come into operation on the 6th day of June 2005 and may be cited as "THE BOROUGH OF BLACKPOOL (VARIOUS RESIDENTS' PARKING SCHEMES) VARIATION ORDER 2004".
