

**BLACKPOOL BOROUGH COUNCIL
THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND
(REVOICATION) No. 8 ORDER 2005**

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

1. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part I of the Second Schedule to the said Order of 2003 and as though the provisions contained in the Third Schedule to this Order were contained in and formed part of the Third Schedule to the said Order of 2003.

2. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Second Schedule to this Order were contained in and formed part of Article 12 to the said Order of 2003.

3. THE NO WAITING restrictions contained in the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far as the length of road referred to in the Fourth Schedule to this Order is concerned.

4. THE SEASONAL NO WAITING restrictions contained in the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far as the length of road referred to in the Fifth Schedule to this Order is concerned.

5. THE ON STREET PAY AND DISPLAY Parking Places provisions contained in the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far as the length of road referred to in the Sixth Schedule to this Order is concerned.

6. ANY provisions contained in the said Order of 2003 and inconsistent with the provisions of Article 1 and 2 of this Order are hereby revoked.



NEW SOUTH PROMENADE - From a point 8m north of the northerly kerbline of the unnamed access road leading to Starr Gate Car & Coach Park and Blackpool Light Craft Club for a distance of 449m in a north-westerly and northerly direction – South-west and west sides

SQUIRES GATE LANE - From a point 7m west of the westerly kerbline of Rutherford Place for a distance of 6m in a westerly direction – North side

UNNAMED ROAD LEADING TO STAR GATE CAR PARK AND BLACKPOOL LIGHT CRAFT CLUB - From the westerly kerbline of New South Promenade for a distance of 49m in a westerly direction – North side
