

**BLACKPOOL BOROUGH COUNCIL**  
**THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS**  
**RESTRICTIONS) AND (REVOCATIONS) NO 5 ORDER 2005**

---

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 3, 4 45, 46, 47, 49, 53 and 124 of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No.2677) and of all other enabling powers hereby make the following Order:-

1. IN this Order, except where the context otherwise requires, the following expressions shall have the meanings hereby assigned to them respectively, that is to say:-

"goods" includes postal packets of any description

"licensed hackney carriage vehicle" means a horse drawn or mechanically propelled hackney carriage licensed under the provisions of the Town Police Clauses Act 1847

"parking attendant" means a parking attendant as defined in section 63A of the Act of 1984 (which is inserted by section 44(1) of the 1991 Act)

"penalty charge" and "reduced penalty charge" means a charge set by the Council following the provisions of section 66 of the 1991 Act and with the approval of the Secretary of State for Transport which is to be paid to the Council within 28 days beginning with the date of the notice or 14 days in the case of a reduced penalty charge following the issue of a penalty charge notice

"penalty charge notice" means a notice issued or served by a parking attendant pursuant to the provisions of section 66 of the 1991 Act containing the particulars therein required

"vehicle" shall not be taken to include non-motor vehicles (other than in the term "licensed hackney carriage vehicle")

2. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, and protection of bus stops) Order 2003 shall have effect as though the provisions contained in the First, Second, Third and Fourth Schedules of this Order were contained in and formed part of Part I of the Second Schedule to the said Order of 2003.

3. NO person shall cause any vehicle to wait other than for the purpose of loading or unloading between the hours of 3.00 a.m. to 6.00 p.m. between 3am and 10:30am in the length of road referred to in the Fifth Schedule of this Order .

4. NOTHING in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in the road or in the lengths of road referred to in the Fifth Schedule hereto for so long as may be necessary:-

- a) if it cannot be used for such purposes in any other length of road, being used in connection with the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near any of the lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus.

- c) if it cannot be used for such purposes in any other length of road, being used in connection with any building or demolition operation.
- d) if it is a Police, fire or ambulance vehicle, which is being used for either police, fire or ambulance purposes where the restriction would be likely to hinder the use of that vehicle in fulfilling that purpose, and which is taking all reasonable precautions.
- e) if it cannot be used for such purposes in any other road, being used or is to be used in the service of a Local Authority or Statutory Undertakers in pursuance of statutory powers or duties.

5. (i) IF a vehicle is left or abandoned in a length of road to which any provision of this Order applies in contravention of any of the provisions of this Order a penalty charge shall be payable and/or the vehicle may be removed from that location

ii) In the case of a vehicle in respect of which a penalty charge is payable a penalty charge notice showing the information required by Section 66(3) of the 1991 Act may then be issued by a parking attendant in accordance with section 66(1) of the 1991 Act

(iii) Where a parking attendant has removed or caused to be removed a vehicle in accordance with paragraph (1) of this Article

- a) he shall provide for the safe custody of the vehicle
- b) the Council shall be entitled to recover from the person responsible such charges in respect of the removal, storage and disposal of the vehicle as it might prescribe from time to time
- c) the provisions of the Road Traffic Regulation Act 1984 as amended shall apply to the disposal of any such vehicle removed by or on behalf of the Council pursuant to this Article

6. ANY provisions contained in the Borough of Blackpool (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 and inconsistent with the provisions of this Order are hereby revoked

7. SAVE as are expressly hereby revoked the provisions of the said Order of 2003 remain in full force and effect


8. THE said Order of 2003 shall be in full force and effect as if the provisions of Article 2 of this Order had originally formed part thereof.

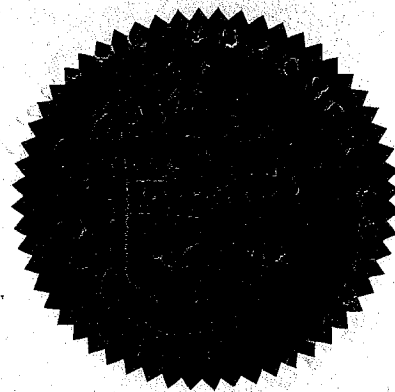
9. THIS Order shall come into operation on the 6<sup>th</sup> day of March 2006 and may be cited as

### First Schedule

#### **NO WAITING AT ANY TIME**

East Pines Drive - From boundary between properties 9 / 11 for a distance of 176 metres in an easterly direction – North Side

East Pines Drive - From a point 325 metres west of Sevenoaks Drive for a distance of 250 metres in an easterly direction – North Side

East Pines Drive - From Sevenoaks Drive to a point 103 metres west of Epsom Road (including access and turning areas adjacent to properties nos. 118, 126, 128, and 110, 112 and 114.) – South Side

East Pines Drive - For a distance of 133 metres east and 34 metres west of Seabrook Drive (including access and turning areas adjacent to properties nos. 82 – 92 inclusive.) – South Side

Sevenoaks Drive - For a distance of 10 metres north and 10 metres south of Warren Drive service road – West Side

Sevenoaks Drive - From Warren Drive for a distance of 10 metres in a northerly direction – Both Sides

Grafton Street - around the turning head at the eastern end, from a point 85m east of Cecil Street (north side) to a point 83m east of Cecil Street (south side)

Preston Old Road – From a point 47m east of the easterly kerb line of Lomond Avenue to Patterdale Avenue – South Side

Island At Junction Of Preston Old Road And Patterdale Avenue – Full length – All sides.

Patterdale Avenue – From Preston Old Road to a point 4m south of boundary property No. 81/83 – West Side.

Preston Old Road – From Patterdale Avenue to boundary of property No. 129/131 – South West side.

Patterdale Avenue – From Preston Old Road to boundary of property No. 129 Preston Old Road and No. 68 Patterdale Avenue – South/ East Side.

### Second Schedule

#### **NO WAITING MONDAY – FRIDAY 10:00 A.M to 4:00 P.M.**

Sevenoaks Drive - From a point 10 metres south of Warren Drive Service Road to a point 10 metres north of Warren Drive – West Side

### Third Schedule

#### **WAITING LIMITED (2 HOURS NO RETURN WITHIN 4 HOURS)**

#### **MONDAY TO FRIDAY BETWEEN 10:00 A.M. AND 4:00 P.M.**

East Pines Drive - From a point 5 m west of Sevenoaks Drive for a distance of 72 metres in a westerly direction – North Side

East Pines Drive - From a point 325 metres west of Sevenoaks Drive for a distance of 98 metres in a westerly direction – North Side

East Pines Drive - From a point 103 metres west of Epsom Road for a distance of 82 metres in a westerly direction – South Side

### Fourth Schedule

#### **WAITING LIMITED (2 HOURS, NO RETURN WITHIN 4 HOURS) MON – SAT 8 A.M. TO 6 P.M.**

East Pines Drive - From a point 34 metres west of Seabrook Drive for a Distance of 51 metres in a westerly direction – South Side

### Fifth Schedule

#### **LOADING ONLY 3AM TO 10:30AM**

CLIFTON STREET – North side – from a point 16m west of Abingdon Street for a distance of 22m in a westerly direction
