BLACKPOOL BOROUGH COUNCIL THE BOROUGH OF BLACKPOOL (ELLAND PLACE) (VARIOUS RESTRICTIONS) and (REVOCATIONS) ORDER 2006

The Council of the Borough of Blackpool in exercise of its powers under Sections 1, 2, 4, 45, 46, 46A, 49, 53, 124 and Part IV of the Ninth Schedule of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "1984 Act") and the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (SI No. 2677) and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with the 1984 Act hereby make the following Order:-

- 1. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part 1 of the Second Schedule to the said Order of 2003.
- 2. THE provisions of Article 7 of The Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far only as the length of road specified in the Third Schedule to this Order is concerned.
- 3. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Second Schedule to this Order were contained in and formed part of the Fifth Schedule to the said Order of 2003.
- 4. THE provisions of Article 84 of The Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far only as the length of road specified in the Fourth Schedule to this Order is concerned.
- 5. SAVE as hereby expressly revoked the provisions Articles 7 and 84 of the said Order of 2003 remain in full force and effect and as if the provisions of Articles 1 and 3 respectively of this Order had originally formed part thereof.
- 6. ANY provisions contained in said Order of 2003 and inconsistent with the foregoing provisions of this Order are hereby revoked.
- 7. THIS Order shall come into operation on the 14th day of April 2006 and may be cited as

"THE BOROUGH OF BLACKPOOL (ELLAND PLACE) (VARIOUS RESTRICTIONS) and (REVOCATIONS) ORDER 2006"

No Waiting At Any Time

ELLAND PLACE - From a point 25m north of northern kerbline of Back Alexandra Road to northern kerbline of back Clare Street – East Side

Areas on highway (or parts of highway) designated as parking places with permits Lytham Road/Central Drive Area

ELLAND PLACE - From the northern kerbline of Back Alexandra Road for a distance of 25m north — East Side

FOURTH SCHEDULE

Revocation of Residents Only Parking
