

**BLACKPOOL BOROUGH COUNCIL**  
**THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND**  
**(REVOCATION) No. 2 ORDER 2006**

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

1. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part 1 of the Second Schedule to the said Order of 2003

2. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Second Schedule to this Order were contained in and formed part of Article 12 to the said Order of 2003.

3. THE said Order of 2003 shall be in full force and effect as if the above provisions had originally formed part thereof.

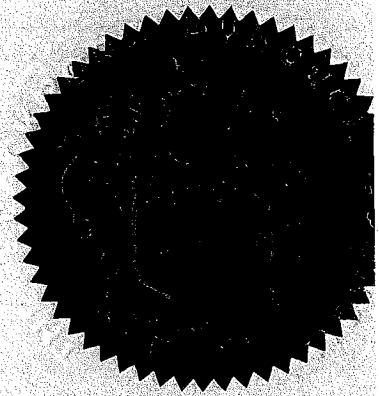
4. THE WAITING restrictions contained in Part 1 of the Second Schedule of the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are revoked so far as the length of road referred to in the Third Schedule to this Order is concerned.

5. ANY provisions contained in the said Order of 2003 and inconsistent with the provisions of this Order are hereby revoked.

6. THIS Order shall come into operation on the first day of April 2006 and may be cited as "THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND (REVOCATION) No. 2 ORDER 2006"

### **FIRST SCHEDULE - NO WAITING AT ANY TIME**

Watson Road, From a point 28m east of Lytham Road to a point 10m west of Lytham Road, South side.

Watson Road, From a point 10m east of Arlington Avenue to a point 10m west of Arlington Avenue, South side

Watson Road, From a point 10m east of Lytham Road to a point 50m west of Lytham Road, North side.

Watson Road, From a point 10m west of Trent Road to a point 10m east of Trent Road, North side

Lytham Road, From a point 16m south of Watson Road to a point 54m north of Watson Road, East side.

Lytham Road, From a point 10m north of Watson Road to a point 46m south of Watson Road, West side.

### **SECOND SCHEDULE - NO LOADING OR UNLOADING AT ANY TIME**

Watson Road, From Lytham Road for a distance of 50m in a westerly direction, North side.

Watson Road, From Lytham Road for a distance of 28m in an easterly direction, South side.

Lytham Road, From Watson Road for a distance of 54m in a northerly direction, East side.

Lytham Road, From Watson Road for a distance of 46m in a southerly direction, West side.

### **THIRD SCHEDULE - REVOCATION OF NO WAITING AT ANY TIME**

Watson Road, For a distance of 9m east and 5m west of Arlington Avenue, South side.
