

BLACKPOOL BOROUGH COUNCIL
THE BOROUGH OF BLACKPOOL (COOKSON STREET & GEORGE STREET) (VARIOUS RESTRICTIONS) AND (REVOCATIONS) ORDER 2006

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 45, 46, 47, 49, 53, 124 and Part IV Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

1 THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part 1 of the Second Schedule to the said Order of 2003.

2 THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Second Schedule to this Order were contained in and formed part of Article 12 of the said Order of 2003

3 THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Third Schedule to this Order were contained in and formed part of Article 30 of the said Order of 2003.

4 THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Fourth Schedule to this Order were contained in and formed part of the Third Schedule to the said Order of 2003.

5 THE said Order of 2003 shall be in full force and effect as if the above provisions had originally formed part thereof.

6 THE provisions relating to no waiting at any time contained in The Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far as the lengths of road referred to in the Fifth Schedule to this Order are concerned.

7 THE provisions relating to No loading at any time contained in The Borough of Blackpool (Various Roads) (Various Restrictions) No.5 Order of 2005 are hereby revoked so far as the lengths of road referred to in the Sixth Schedule to this Order are concerned.

8 THE provisions relating to No loading 10:30am to 6:00pm contained in The Borough of Blackpool (Various Roads) (Various Restrictions) No.11 Order of 2004 are revoked so far as the lengths of road referred to in the Seventh Schedule to this Order are concerned.

9 THE provisions relating to Loading Only Bays (24 hours) 15 minutes, no return within 30 minutes, contained in The Borough of Blackpool (Town Centre) (Various Restrictions) Order of 2004 are hereby revoked so far as the lengths of road referred to in the Eighth Schedule to this Order are concerned.

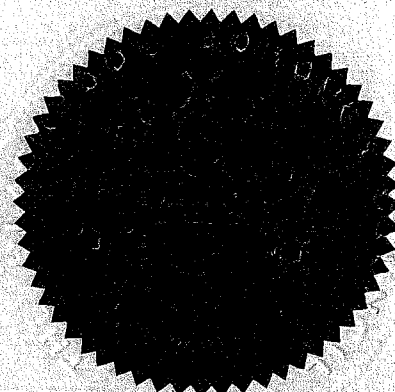

11. ANY provisions contained in the said Order of 2003 and inconsistent with the provisions of this Order are hereby revoked.

12. THIS Order shall come into operation on the 9th day of October 2006 and may be cited as "THE BOROUGH OF BLACKPOOL (COOKSON STREET & GEORGE STREET) (VARIOUS RESTRICTIONS) AND (REVOCATIONS) ORDER 2006

COOKSON STREET - From a point 5m north of Milbourne Street to a point 10m south of Charles Street – West side

COOKSON STREET - From a point 5m north of Charles Street for a distance of 10m north – West side

- COOKSON STREET - Church Street to 4m north of Milbourne Street – East side

- COOKSON STREET From 20m south of George Street to Talbot Road – East side

SIXTH SCHEDULE

REVOCATION OF NO LOADING AT ANY TIME

- COOKSON STREET - Counce Street for a distance of 15m north – Both
