

## **THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND (REVOCATION) ORDER 2007**

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 3, 4, 124 and Part IV Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

1. IN this Order, except where the context otherwise requires, the following expressions shall have the meanings hereby assigned to them respectively, that is to say –

penalty charge" and "reduced penalty charge" means a charge set by the Council under the provisions of Section 66 of the 1991 Act and with the approval of the Secretary of State for Transport which is to be paid to the council within 28 days beginning with the date of the notice or 14 days in the case of a reduced penalty charge following the issue of a penalty charge notice.

"penalty charge notice" means a notice issued or served by a parking attendant pursuant to the provisions of Section 66 of the 1991 Act containing the particulars therein required.

"parking attendant" means a parking attendant as defined in section 63A of the Act of 1984 (which is inserted by Section 44(1) of the 1991 Act).

"school entrance" means the length of road which is marked with the road marking complying with Diagram 1027.1 and which is signed with a sign complying with Diagram 642.2A of the Traffic Signs Regulations and General Directions 2002 and specified in the first column of the Second Schedule to this Order

"vehicle" shall not be taken to include non-motor vehicles

2. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part 1 of the Second Schedule to the said Order of 2003.

3. THE said Order of 2003 shall be in full force and effect as if the above provisions had

originally formed part thereof.

4. SAVE as provided in Article 5 of this order no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to stop on the school entrance on the days and during the hours specified in the Second Schedule to this Order.

5. NOTHING in Article 4 shall render it unlawful for a person to cause or permit a vehicle to stop on the school entrance if

(a) it is being used for as long as may be necessary for emergency Fire and Rescue Service, Ambulance or Police purposes;

(b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control, or the driver has been told to wait by a police constable in uniform, or such waiting is necessary in order to avoid an accident;

6. (1) IF a vehicle is left or abandoned in the length of road referred to in the Second Schedule of this Order and in contravention of any of the provisions of Article 4 of this Order, a penalty charge shall be payable; the vehicle may also be removed from that location.

(2) In the case of a vehicle in respect of which a penalty charge is payable a penalty charge notice showing the information required by Section 66(3) of the 1991 Act may then be issued by a parking attendant in accordance with Section 66(1) of the 1991 Act.

(3) Where a parking attendant has removed or caused to be removed a vehicle in accordance with paragraph (1) of this Article

(a) he shall provide for the safe custody of the vehicle;(b) the Council shall be entitled to recover from the person responsible such charges in respect of the removal, storage and disposal of the vehicle as it might prescribe from time to time;

(c) the provisions of the Road Traffic Regulation Act.1984 as amended shall apply to the disposal of any such vehicle removed by or on behalf of the Council pursuant to this Article.

7. NOTWITHSTANDING the provisions of this Order, the Council may at its discretion (including requiring an administration fee) issue a dispensation allowing a specific vehicle to

wait in the length of road, to which the provisions of Article 4 of this Order applies during the hours of operation of the restriction or prohibition to the contrary.

8. THE provisions relating to no waiting at any time contained in The Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far as the length of road referred to in the Third Schedule to this Order is concerned.

9. THE provisions relating to No Stopping 8:00am to 5:00pm, Mondays to Fridays on School entrance markings contained in The Borough of Blackpool (Various Roads) (Various Restrictions) No.2 Order of 2004 are hereby revoked so far as the length of road referred to in the Fourth Schedule to this Order is concerned.

10. ANY provisions contained in the said Order of 2003 and inconsistent with the provisions of this Order are hereby revoked.

11. THIS Order shall come into operation on the 20<sup>th</sup> day of April 2007 and may be cited as "THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND (REVOCATION) ORDER 2007"

CONDOR GROVE – Both sides – From the easterly kerbline of Queen Victoria Road for a distance of 10m east

GRASMERE ROAD – East side – From a point 15m south of the southerly kerbline of Wyre Grove to a point 15m north of the northerly kerbline of Wyre Grove

LEVENS GROVE – Both sides – From the easterly kerbline of Queen Victoria Road for a distance of 10m east

LUNE GROVE – North side – From the easterly kerbline of Queen Victoria Road for a distance of 10m east

MAYOR AVENUE – Both sides – From the westerly kerbline of Queen Victoria Road for a distance of 10m west

PALMER AVENUE – Both sides – From the westerly kerbline of Queen Victoria Road for a distance of 10m west

QUEEN VICTORIA ROAD – East side – From a point 10m south of the southerly kerbline of Condor Grove to a point 10m north of the northerly kerbline of Condor Grove

QUEEN VICTORIA ROAD – East side – From a point 10m south of the southerly kerbline of Bela Grove to a point 10m north of Bela Grove

QUEEN VICTORIA ROAD – East side – From the southerly kerbline of Wyre Grove for a distance of 10m south

QUEEN VICTORIA ROAD – East side – From the northerly kerbline of Lune Grove for a distance of 10m north

QUEEN VICTORIA ROAD – West side – From a point 10m south of the southerly kerbline of Palmer Avenue to a point 10m north of the northerly kerbline of Palmer Avenue

QUEEN VICTORIA ROAD – West side – From a point 10m south of the southerly kerbline of Mayor Avenue to a point 10m north of the northerly kerbline of Mayor Avenue

QUEEN VICTORIA ROAD – West side – From the northerly kerbline of Wyre Grove for a distance of 20m south

WYRE GROVE – North side – From the westerly kerbline of Queen Victoria Road for a distance of 20m east

WYRE GROVE – South side – From the easterly kerbline of Queen Victoria Road for a distance of 14m east

WYRE GROVE – Both sides – From the easterly kerbline of Grasmere Road for a distance of 10m east

WYRE GROVE – Both sides – From the westerly kerbline of Grasmere Road for a distance of 12m west
