## THE BOROUGH OF BLACKPOOL (PROMENADE) (TAXI STAND) ORDER 2007

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 3, 4, 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No.2677) and of all other enabling powers hereby make the following Order:-

<u>1.</u> <u>THE</u> WAITING/NO WAITING restrictions contained in Part I of the Second Schedule of the Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 are hereby revoked so far as the length of road and the times referred to in the Third Schedule to this Order are concerned.

2. THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents' Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the Second Schedule to this Order were contained in and formed part of Part 1 of the Second Schedule to the said Order of 2003

<u>3.</u> <u>THE</u> said Order of 2003 shall be in full force and effect as if the provisions of Article 2 hereof had originally formed part thereof.

<u>4. THE</u> Borough of Blackpool (Various Locations) (Consolidation of Taxis Stands) Traffic Regulation Order 2006 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of the First Schedule to the said Order of 2006.

<u>5.</u><u>THE</u> said Order of 2006 shall be in full force and effect as if the provisions of Article 4 hereof had originally formed part thereof.

6. ANY provisions contained in the said Order of 2003 and inconsistent with the rovisions of Articles 2 to 5 (inclusive) of this Order are hereby revoked.

<u>7. ANY</u> provisions contained in the said Order of 2006 and inconsistent with the provisions of Article 2 to 5 (inclusive) of this Order are hereby revoked.

<u>8.</u> <u>SAVE</u> as are expressly hereby revoked the provisions of the said Order of 2003 and the said Order of 2006 remain in full force and effect

<u>9.</u> <u>THIS</u> Order shall come into operation on the 18<sup>th</sup> day of June 2007 and may be cited as "THE BOROUGH OF BLACKPOOL (PROMENADE) (TAXI STAND) ORDER 2007"
