BLACKPOOL BOROUGH COUNCIL THE BOROUGH OF BLACKPOOL (CEDAR SQUARE) (PEDESTRIAN AREA) ORDER 2008

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4 and 124 and Part IV of the Road Traffic Regulation Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 hereby make the following Order:-

<u>1. THIS</u> Order shall come into operation on the 22nd day of January 2009 and may be cited as '**THE BOROUGH OF BLACKPOOL (CEDAR SQUARE) (PEDESTRIAN AREA) ORDER 2008**"

<u>2.</u> IN this Order except where the context otherwise requires the following expressions shall have the meanings assigned to them respectively, that is to say:-

"vehicle" means a motor vehicle.

<u>3.</u> <u>SAVE</u> as provided in Article 4 of this Order no person shall cause or permit any vehicle to enter or proceed at any time in any of the lengths of road described in the First Schedule to this Order

<u>4.</u> (1) NOTHING in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to enter or proceed in any of the lengths of road referred to in the First Schedule to this Order for so long as may be necessary:-

(a) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths or road so referred to or the laying, erection or alteration or repair in or near to any of the said lengths or road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraph apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in the Second Schedule to the Telecommunications Act 1984;

(b) is being used for by the Fire Brigade, Ambulance or Police purposes or in the service of the council in pursuance of statutory powers or duties

(2) Furthermore and in addition nothing in Article 3 of this Order shall render it unlawful for a vehicle to enter or proceed along any of the lengths of road referred to in the first Schedule to this Order between the hours of 6.00pm and 10.30am if the vehicle is in use for the purpose of servicing premises adjoining, abutting or situate off any of the lengths of road where no suitable alternative means of access is available.

(3) Furthermore and in addition nothing in Article 3 of this Order shall render it unlawful for a person to cause or permit a vehicle to proceed along any of the lengths of road referred to in the first schedule to this Order at any time if:-

(a)

owned by a funeral director and in use as part of a funeral cortège

- (b) being used in official capacity in connection with the conduct of a Wedding or Civil Partnership
- (c) any vehicle authorised by the council and displaying a valid permit issued by the council.
