BLACKPOOL BOROUGH COUNCIL THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (PROHIBITION OF WAITING) AND (REVOCATION) ORDER 2010

The Council of the Borough of Blackpool (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984 and in exercise of its powers under the Road Traffic Act 1991, the Traffic Management Act 2004 and the Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and of all other enabling powers hereby make the following Order:-

- THE Borough of Blackpool (Various Roads) (Consolidation of Waiting Restrictions, On Street Parking Places, Residents Parking Places and Protection of Bus Stops) Order 2003 shall have effect as though the provisions contained in the First Schedule to this Order were contained in and formed part of Part 1 of the Second Schedule to the said Order of 2003.
- THE said Order of 2003 shall be in full force and effect as if the above provisions had originally formed part thereof
- THE provisions relating to No Waiting at Any Time contained in the said Order of 2003 are hereby revoked so far only as the lengths of road and the times specified in the Second Schedule to this Order are concerned.
- THIS Order shall come into operation on the 29th day of March 2010 and may be cited as

"THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (PROHIBITION OF WAITING) AND (REVOCATION) ORDER 2010".

NO WAITING AT ANY TIME

PRINCES WAY from the western kerb line of Queens Promenade for a distance of 150m in a westerly then northerly direction (both sides)

SHORE ROAD from the eastern kerb line of Queens Promenade for a distance of 25m in an easterly direction (both sides)

QUEENS PROMENADE from a point 62m south of the southern kerb line of Wilvere Drive for a distance of 162m in a northerly direction (west side)

QUEENS PROMENADE from the southern kerb line of Wilvere Drive for a distance of 62m in a southerly direction (east side)

QUEENS PROMENADE from the northern kerb line of Wilvere Drive to the southern kerb line of Shore Road (east side)

QUEENS PROMENADE from the northern kerb line of Shore Road for a distance of 49m in a northerly direction (east side)

WILVERE DRIVE from the eastern kerb line of Queens Promenade for a distance of 32m in an easterly direction (both sides)
