THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND (REVOCATIONS) ORDER 2013

THE COUNCIL OF THE BOROUGH OF BLACKPOOL (hereafter referred to as 'the Council') under Section 1, 2, 3, 4, 45, 46, 47, 49, 53 and 124 of the Road Traffic Regulation Act 1984 (hereafter referred to as the 'Act of 1984), the Traffic Management Act 2004 and The Road Traffic (Permitted Parking Area and Special Parking Area) (Borough of Blackpool) Order 2003 (Statutory Instrument No 2677) and after consultation with the Chief Officer of Police pursuant to Part III of Schedule 9 of the Act of 1984 and all other enabling powers hereby propose to make the above Order.

1. (a) IN this Order except where the content otherwise expressly requires the following words or expressions shall have these meanings assigned to them:"a person authorised by the Council" means a police constable in uniform or a civil

enforcement officer in uniform.

"Civil Enforcement Officer" means a person in uniform authorised by the Council to supervise any parking place.

"disabled person's badge" shall have the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 as amended by the Disabled Persons (Badges for Motor Vehicles) (England) (Amendment) Regulations 2000 that has not ceased to be in force.

"disabled persons parking disc" means a device which:-

- a) is 125 millimetres square and coloured blue;
- b) has been issued by a local authority and has not ceased to be valid; and
- c) is capable of showing the quarter hour period during which a period has begun as described in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

"disabled persons vehicle" means a vehicle which displays in the relevant position a disabled person's badge in accordance with the circumstances prescribed in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 as amended.

"invalid carriage" means the same as in Section 136 (5) of the Road Traffic Regulation Act 1984.

"penalty charge notice" means a notice issued or served by a Civil Enforcement Officer pursuant to the provisions Part 6 of the Traffic Management Act 2004 containing the provisions therein required.

"Relevant Position" shall have the following meanings:-

- (a) on the dashboard or facia of the vehicle so that the font of the badge is clearly legible from the outside of the vehicle; or
- (b) where the vehicle is not fitted with a dashboard or facia in a conspicuous position on the vehicle so that the front of the badge is clearly legible from the outside of the
- (c) on the windscreen so that the front of the badge is clearly legible from the outside of
- (d) in each case for the avoidance of doubt so that no letter, numeral or symbol on the front of the badge is obscured.

"servicing" means the conveyance of equipment, goods or merchandise to or from a premise or for carrying out maintenance works to a premise.

"Universal Service Provider" shall have the same meaning as in the Postal Services Act 2000.

"vehicle" shall not be taken to include non-motor vehicles.

- SAVE as provided in Article 5 or Article 6 of this Order no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise permit any vehicle to wait at any time in any of the lengths of road described in Schedule 1 to this Order.
- SAVE as provided in Article 5 or Article 6 of this Order no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise permit any vehicle to wait in any of the lengths of road described in Schedule 2 to this Order on the days and during the times specified therein.
- SAVE as provided in Article 5 or Article 6 of this Order no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise

permit any vehicle to wait in any of the lengths of road described in Schedule 3 to this Order on the days and during the times specified therein.

- 5. NOTHING in Article 2, Article 3 and Article 4 of this Order shall render it unlawful to cause or permit a vehicle to wait in any of the lengths of road referred to in Schedule 1, Schedule 2 and Schedule 3 to this Order for so long as may be reasonably necessary:-
 - (a) to enable a person to board or alight from the vehicle or load thereon or unload there from their personal luggage;
 - (b) if the vehicle is being used by the Fire and Rescue Service, Ambulance Service or Police Service in pursuance of statutory powers or duties and in an emergency;
 - (c) if the vehicle, not being a passenger carrying vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties provided that it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;
 - (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building or demolition operations, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection or alteration or repair in or near to any of the said lengths of roads or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraph apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in the Second Schedule to the Telecommunications Act 1984;
 - (e) if the vehicle is bearing a livery which is used by a Universal Service Provider and the vehicle is engaged in the collection and/or delivery of letters in accordance with statutory duty for the provision of services for the conveyance of letters;
 - (f) if the vehicle is waiting only while a gate or barrier is opened or closed to allow access or departure to or from adjacent premises;
 - (g) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control, or the driver has been told to wait by a police constable in uniform, or such waiting is necessary in order to avoid an accident.
- 6. NOTHING in Article 2, Article 3 and Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to in Schedule 1, Schedule 2 and Schedule 3 of this Order on the days and during the times specified therein in relation to that length of road
 - (a) if the vehicle is a disabled persons vehicle which displays in the Relevant Position a disabled persons badge and a disabled persons parking disc which said disc is (i) exhibited on the dashboard or facia of the vehicle or (ii) where the vehicle is not fitted

with a dashboard or facia, the disc is exhibited in a conspicuous position on the vehicle so that in either case, when marked to show the quarter hour period during which the period of waiting began, that period is clearly legible from outside the vehicle, on which the driver or other person in charge of the vehicle has marked the quarter hour period during which the period of waiting began, for a period not exceeding **three hours** and not being a period separated by an interval of less than **one hour** from a previous period of waiting by the same vehicle in the same length of road on the same day.

(b) If the vehicle is an invalid carriage.

7.	SAVE as provided in Article 10 of this Order no person except under the direction or
with t	he permission of a person authorised by the Council shall cause or otherwise permit any
	e to wait at any time in any of the lengths of road described in Schedule 4 of this Order
for the	e purpose of loading and/or unloading.

- 8. SAVE as provided in Article 10 of this Order no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise permit any vehicle to wait in any of the lengths of road described in Schedule 5 of this Order on the days and during the times specified therein for the purpose of loading and/or unloading.
- 9. SAVE as provided in Article 10 of this Order no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise permit any vehicle to wait in any of the lengths of road described in Schedule 6 of this Order on the days and during the times specified therein for the purpose of loading and/or unloading.
- 10. NOTHING in Article 7, Article 8 and Article 9 of this Order shall render it unlawful for a vehicle to wait in any of the lengths of road referred to therein for so long as may be reasonably necessary:-
 - (a) to enable a person to board or alight from the vehicle or load thereon or unload there from their personal luggage;
 - (b) if the vehicle is being used by the Fire and Rescue Service, Ambulance Service or Police Service in pursuance of statutory powers or duties and in an emergency;
 - (c) if the vehicle, not being a passenger carrying vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties provided that it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;
 - (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building or demolition operations, the removal

of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection or alteration or repair in or near to any of the said lengths of roads or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraph apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in the Second Schedule to the Telecommunications Act 1984;

- (e) if the vehicle is bearing a livery which is used by a Universal Service Provider and the vehicle is engaged in the collection and/or delivery of letters in accordance with statutory duty for the provision of services for the conveyance of letters;
- (f) if the vehicle is waiting only while a gate or barrier is opened or closed to allow access or departure to or from adjacent premises;
- (g) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control, or the driver has been told to wait by a police constable in uniform, or such waiting is necessary in order to avoid an accident.
- 11. THE Borough of Blackpool (Various Locations) (Taxi Stands) Order 2012 shall have effect as though the provisions contained in Schedule 7 to this Order were contained in and formed part of the First Schedule to the 2012 Order.
- 12. THE said Order of 2012 shall be in full force and effect as though the provision of Article 11 and Schedule 7 hereto had originally formed part of the said Order of 2012.
- 13. (a) SAVE as provided in Article 14 and Article 15 to this Order no person except under the direction or with the permission of a Civil Enforcement Officer or a police constable in uniform shall cause or otherwise permit any vehicle on the days and during the times specified in Schedule 8 to this Order
 - (i) to wit in the length of road described in Schedule 8 to this Order for a period longer than ninety minutes or (ii) to return for a further period if a period of less than three hours has elapsed since the termination of the last period of waiting on the same vehicle on the last described length of road.
- (b) SAVE as provided in Article 14 and Article 15 to this Order no person except under the direction or with the permission of a Civil Enforcement Officer or a police constable in uniform shall cause or otherwise permit any vehicle:
 - (i) to wait at any time in any of the lengths of road described in Schedule 9 of this Order for a period longer than fifteen minutes or (ii) to return for a further period if a period of less than thirty minutes has elapsed since the termination of the last period of waiting of the same vehicle on the same length of road.

of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection or alteration or repair in or near to any of the said lengths of roads or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraph apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in the Second Schedule to the Telecommunications Act 1984;

- (e) if the vehicle is bearing a livery which is used by a Universal Service Provider and the vehicle is engaged in the collection and/or delivery of letters in accordance with statutory duty for the provision of services for the conveyance of letters;
- (f) if the vehicle is waiting only while a gate or barrier is opened or closed to allow access or departure to or from adjacent premises;
- (g) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control, or the driver has been told to wait by a police constable in uniform, or such waiting is necessary in order to avoid an accident.
- 11. THE Borough of Blackpool (Various Locations) (Taxi Stands) Order 2012 shall have effect as though the provisions contained in Schedule 7 to this Order were contained in and formed part of the First Schedule to the 2012 Order.
- 12. THE said Order of 2012 shall be in full force and effect as though the provision of Article 11 and Schedule 7 hereto had originally formed part of the said Order of 2012.
- 13. (a) SAVE as provided in Article 14 and Article 15 to this Order no person except under the direction or with the permission of a Civil Enforcement Officer or a police constable in uniform shall cause or otherwise permit any vehicle on the days and during the times specified in Schedule 8 to this Order
 - (i) to wit in the length of road described in Schedule 8 to this Order for a period longer than ninety minutes or (ii) to return for a further period if a period of less than three hours has elapsed since the termination of the last period of waiting on the same vehicle on the last described length of road.
- (b) SAVE as provided in Article 14 and Article 15 to this Order no person except under the direction or with the permission of a Civil Enforcement Officer or a police constable in uniform shall cause or otherwise permit any vehicle:
 - (i) to wait at any time in any of the lengths of road described in Schedule 9 of this Order for a period longer than fifteen minutes or (ii) to return for a further period if a period of less than thirty minutes has elapsed since the termination of the last period of waiting of the same vehicle on the same length of road.

the driver or other person in charge of the vehicle has marked the quarter hour period during which the period of waiting began, for a period not exceeding **15 minutes** and not being a period separated by an interval of less than **30 minutes** from a previous period of waiting by the same vehicle in the same length of road on the same day.

- (b) If the vehicle is an invalid carriage.
- 16. (a) SAVE as provided in Article 17 and Article 18 of this Order or paragraph (b) of this Article no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise permit any vehicle to wait in the lengths of road specified in Schedule 10 of this Order at any time.
- (b) NOTHING in paragraph (a) of this Article shall render it unlawful for a vehicle to wait in the length of road referred to therein if the vehicle is being used for the purpose only of loading and/or unloading goods to adjoining premises and if (i) that period of waiting does not exceed fifteen minutes and (ii) at least thirty minutes has elapsed since the termination of the previous period of waiting of the same vehicle in the last described length of road.
- 17. NOTHING in Article 16 of this Order shall render it unlawful for a vehicle to wait in any of the lengths of road referred to therein for so long as may be reasonably necessary:-
 - (a) to enable a person to board or alight from the vehicle or load thereon or unload there from their personal luggage;
 - (b) if the vehicle is being used by the Fire and Rescue Service, Ambulance Service or Police Service in pursuance of statutory powers or duties and in an emergency;
 - (c) if the vehicle, not being a passenger carrying vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties provided that it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;
 - (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building or demolition operations, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection or alteration or repair in or near to any of the said lengths of roads or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraph apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in the Second Schedule to the Telecommunications Act 1984;
 - (e) if the vehicle is bearing a livery which is used by a Universal Service Provider and the vehicle is engaged in the collection and/or delivery of letters in accordance with statutory duty for the provision of services for the conveyance of letters;

- (f) if the vehicle is waiting only while a gate or barrier is opened or closed to allow access or departure to or from adjacent premises;
- (g) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control, or the driver has been told to wait by a police constable in uniform, or such waiting is necessary in order to avoid an accident.
- 18. NOTHING in Article 16 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to in Schedule 10 of this Order on the days and during the times specified therein in relation to that length of road
 - (a) if the vehicle is a disabled persons vehicle which displays in the Relevant Position a disabled persons badge and a disabled persons parking disc which said disc is (i) exhibited on the dashboard or facia of the vehicle or (ii) where the vehicle is not fitted with a dashboard or facia, the disc is exhibited in a conspicuous position on the vehicle so that in either case, when marked to show the quarter hour period during which the period of waiting began, that period is clearly legible from outside the vehicle, on which the driver or other person in charge of the vehicle has marked the quarter hour period during which the period of waiting began, for a period not exceeding 15 minutes and not being a period separated by an interval of less than 30 minutes from a previous period of waiting by the same vehicle in the same length of road on the same day.
 - (b) If the vehicle is an invalid carriage.
- 19. THE Borough of Blackpool (Various Road) (Consolidation Of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, And Protection of Bus Stops) Order 2003 shall have effect as though the Areas on Highways specified in Schedule 11 and Schedule 12 hereto were included in the Fifth Schedule of the said Order of 2003 and formed part of the Ibbison Court/Kent Road Area therein.
- 20. THE Borough of Blackpool (Various Road) (Consolidation Of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, And Protection of Bus Stops) Order 2003 shall have effect as though the Areas on Highways specified in Schedule 13 hereto were included in the Sixth Schedule of the said Order of 2003 and formed part of the Ibbison Court/Kent Road Area therein.
- 21. THE Borough of Blackpool (Various Road) (Consolidation Of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, And Protection of Bus Stops) Order 2003 shall have effect as though Schedule 12 hereto formed the Sixteenth Schedule of the said Order of 2003.

- 22. THE Borough of Blackpool (Various Road) (Consolidation Of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, And Protection of Bus Stops) Order 2003 shall have effect as though the following provisions were contained in and formed Article 113A of the said Order of 2003.
- 113A) (a) SAVE as provided in paragraph (b) and (c) of this Article to this Order no person except under the direction or with the permission of a person authorised by the Council shall cause or otherwise permit a vehicle to wait at any time in any of the lengths of road described in the Sixteenth Schedule of this Order.
 - (b) <u>NOTHING</u> contained within paragraph (a) of this Article shall render it unlawful for a vehicle to wait in a length of road described in the Sixteenth Schedule of this Order between the hours of 8am and 6pm Monday to Saturday inclusive if that period of waiting does not exceed two hours and if the vehicle does not return for a further period of waiting until a minimum of four hours has elapsed since the termination of the last period of waiting of the same vehicle in the same length of road.
 - (c) <u>NOTWITHSTANDING</u> the provisions contained in paragraph (a) of this Article, any vehicle displaying a valid residents or visitors parking permit may wait for any length of time on the lengths of road described in the Sixteenth Schedule of this Order.
- 23. THE Borough of Blackpool (Various Road) (Consolidation Of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, And Protection of Bus Stops) Order 2003 shall have effect as though
 - (i) The words "and 113A" were included in Article 114 thereof after the words "and 112"
 - (ii) The words "to Fifteenth" in Article 84 thereof were replaced with the words "to Sixteenth"
- 24. THE said Order of 2003 shall be in full force and effect as though the provision of Article 19, Article 20, Article 21, Article 22, Article 23, Schedule 11, Schedule 12 and Schedule 13 of this Order had originally formed part of the said Order of 2003.
- 25. THE Borough of Blackpool (Whitegate Drive Area) (Residents Parking Area) Order 2011 shall have effect as though the provisions contained in Schedule 14 to this Order were contained in and formed part of the First Schedule to the 2011 Order.

THE Borough of Blackpool (Whitegate Drive Area) (Residents Parking Area) Order 2011 shall have effect as though the provisions contained in Schedule 15 to this Order were contained in and formed part of the Third Schedule to the 2011 Order. THE said Order of 2011 shall be in full force and effect as though the provision of 27. Article 25, Article 26, Schedule 14 and Schedule 15 hereto had originally formed part of the said Order of 2011. THE said Order of 2006 shall be in full force and effect as though the provision of Article 30 and Schedule 17 hereto had originally formed part of the said Order of 2006. THE no waiting at any time restrictions contained in Part 1 of the Second Schedule of The Borough Of Blackpool (Various Roads) (Consolidation Of Waiting Restrictions, On Street Parking Places, Residents' Parking Places, And Protection Of Bus Stops) Order 2003 are revoked insofar only as the lengths of road specified in Schedule 18 hereto are concerned. THE pay and display with waiting limited restrictions contained in the Fifth Schedule (Outer Zone) of The Borough Of Blackpool (Town Centre) (On-Street Pay And Display Parking Places) Order 2006 are revoked insofar only as the lengths of road specified in Schedule 19 hereto are concerned. THE no waiting at any time restrictions contained in the First Schedule of The Borough Of Blackpool (Various Roads) (Various Restrictions) No 4 Order 2005 and the no loading/unloading at any time restrictions contained in the Second Schedule of the said Order

of 2005 are revoked insofar only as the lengths of road specified in Schedule 20 hereto are concerned.

- 35. THE no waiting at any time restrictions contained in the Sixth Schedule of The Borough Of Blackpool (Promenade) (Various Restrictions) And (Revocations) Order 2011 and the limited waiting at any time restrictions contained in the Third Schedule of the last said Order of 2011 are revoked insofar only as the lengths of road specified in Schedule 21 hereto are concerned.
- 36. THE no waiting at any time restrictions contained in the First Schedule of The Borough Of Blackpool (Various Roads) (Various Restrictions) And (Revocations) No 2 Order 2011, and the no waiting Monday to Friday restrictions contained in the Eighth Schedule of the last said Order of 2011 and the no loading/unloading restrictions contained in the Fifteenth Schedule of the last said Order of 2011 are revoked insofar only as the lengths of road specified in Schedule 22 hereto are concerned.
- 37. THE no stopping except taxis at any time restrictions contained in the First Schedule of The Borough Of Blackpool (Various Locations) (Taxi Stands) Order 2012 are revoked insofar only as the lengths of road specified in Schedule 23 hereto are concerned.
- 38. THE no waiting at any time restrictions contained in the First Schedule of The Borough Of Blackpool (Various Roads) (Various Restrictions) And (Revocations) No2 Order 2012 and the no loading/unloading at any time restrictions contained in the Fourth Schedule of the last said Order of 2012 are revoked insofar only as the lengths of road specified in Schedule 24 hereto are concerned.
- 39. THIS Order shall come into operation on the 6th December 2013 and may be cited as "THE BOROUGH OF BLACKPOOL (VARIOUS ROADS) (VARIOUS RESTRICTIONS) AND (REVOCATIONS) ORDER 2013"
