

**THE BOROUGH OF BOURNEMOUTH

The Council of the Borough of Bournemouth ("the Council"),

- in exercise of its powers under the Local Authorities' Traffic Orders(Procedure)(England and Wales) Regulations 1996 ("the regulation") and of all other enabling powers, and
 - after consultation with the Chief Officer of Police,
- hereby makes the following Order:-

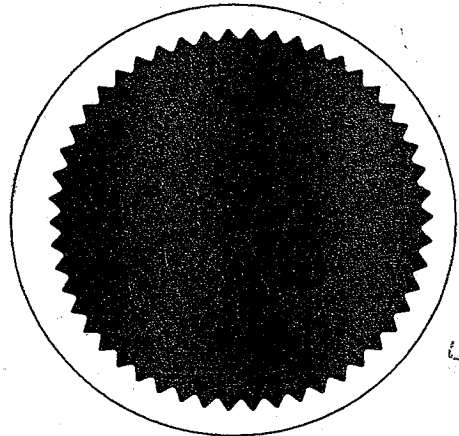
1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 is hereby varied by;
 - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
 - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

This Order shall come into operation on the 29th May, 2006 and may be cited as : THE BOROUGH OF BOURNEMOUTH (PARKING REGULATION ORDER) (CONSOLIDATION) ORDER 2004 (VARIATION) (NO.2) ORDER 2006

the northwestern side, from a point 1 metre northeast of the extended boundary of Nos. 56/58 to a point 15.1 metres northeast of the boundary of Nos. 19/23

the southeastern side, from a point 10 metres northeast of the boundary of Nos 40/42 for a distance of 109 metres southwest

the western side, from its junction with the Lansdowne roundabout for a distance of 12 metres in a southerly direction

HOLDENHURST ROAD

SCHEDULE 101 : Waiting prohibited at any time

- (i) the northwestern side, from a point 38 metres northeast of the boundary of Nos. 19/23 for a distance of 5 metres in a north-easterly direction

SCHEDULE 318 : Waiting limited to 1 hour 10am-7pm return prohibited within 1 hour

- (i) the northwestern side, from a point 15 metres northeast of the boundary of Nos. 19/23 to a point 38 metres northeast of the boundary of Nos. 19/23
- (ii) the northwestern side, from a point 1 metre northeast of the extended boundary of Nos. 56/58 to a point 43 metres northeast of the boundary of Nos. 19/23
- (iii) the southeastern side, from a point 10 metres northeast of the boundary of Nos. 40/42 to a point 24 metres northeast of the extended boundary of Nos. 11/13

SCHEDULE 709 : Loading Bay

- (i) the southeastern side, from the extended boundary of Nos. 11/13 for a distance of 24 metres in a north-easterly direction

MEYRICK ROAD

SCHEDULE 101 : Waiting prohibited at any time

- (i) the western side, from its junction with Bath Road to a point 63 metres north of the northern boundary of Garden House

SCHEDULE 801 : Waiting prohibited at any time except for Hackney Carriages

- (i) the western side, from a point 63 metres north of the northern boundary Garden House for a distance of 22 metres in a southerly direction
