- 1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2006 is hereby varied by:
  - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
  - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
- 2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2006 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
- 3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 4. This Order shall come into operation on the 25<sup>th</sup> June, 2007 and may be cited as: BOURNEMOUTH BOROUGH COUNCIL (PARKING REGULATION ORDERS) (CONSILIDATION) ORDER 2006 (VARIATION) (NO. 3) (PART 1) ORDER 2007

SCHEDULE 101: Waiting prohibited at any time

(i) the northwestern side, from the access road to Muscliff Primary School to a point 6 metres southwest of the boundary of Nos. 115/117

#### **COPSEWOOD AVENUE**

SCHEDULE 129: Waiting prohibited Mon-Fri 10am-11am and 3pm-4pm

(i) both sides, from its junction with Parkway Drive for a distance of 10 metres in a northerly direction

#### **OVERSTRAND CAR PARK ACCESS ROAD**

SCHEDULE 201: Waiting and loading/unloading prohibited at any time
