
The Council of the Borough of Bournemouth ("the Council"),

- in exercise of its powers under section 22 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 ("the Regulations") and of all other enabling powers, and
- after consultation with the Chief Officer of Police, hereby makes the following Order:-
- 1. The Borough of Bournemouth (Parking Regulation Orders) (Consolidation) Order 2006 is hereby varied by;
 - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
 - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
- 2. The Borough of Bournemouth (Parking Regulation Orders) (Consolidation) Order 2006, as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
- 3. The provisions of Articles 1 and 2 of this Order may be varied or amended within the regulations governing Experimental Orders. The persons authorised to agree such variations or amendments are: The Chief Constable of the Dorset Police and the Director of Environment and Community Services of the Bournemouth Borough Council, or such of their Officers as they may so authorise.
- 4. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 5. This Order shall come into operation on the 27th June 2008 and may be cited as: The Borough of Bournemouth (Parking Regulation Orders) (Experimental) (Sea Road) Order 2008
