
The Council of the Borough of Bournemouth ("the Council"),

- in exercise of its powers under the Local Authorities' Traffic Orders(Procedure)(England and Wales) Regulations 1996 ("the regulation") and of all other enabling powers, and
 - after consultation with the Chief Officer of Police,
- hereby makes the following Order:-

1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2009 is hereby varied by;
 - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
 - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2009 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 29th March 2010, and may be cited as :

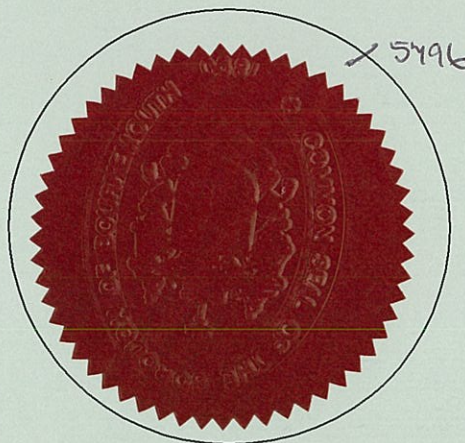

BEECHWOOD AVENUE

SCHEDULE 1.01

the eastern side, from its junction with Parkwood Road for a distance of 10 metres

the western side, from its junction with Parkwood Road to its junction with Beechwood Gardens

DARRACOTT ROAD

both sides, from its junction with Parkwood Road for a distance of 10 metres

PARKWOOD ROAD

the northern side, from a point 27 metres west to a point 40 metres east of the centre line of
Beechwood Avenue

the southern side, from a point 16 metres west to a point 30 metres east of the centre line of
Beechwood Avenue

BEECHWOOD AVENUE

SCHEDULE 2.03 : Waiting and loading/unloading prohibited at any time

- (i) the eastern side, from its junction with Parkwood Road for a distance of 26 metres south
- (ii) the western side, from its junction with Parkwood Road to its junction with Beechwood Gardens

DARRACOTT ROAD

SCHEDULE 2.03 : Waiting and loading/unloading prohibited at any time

- (i) the northwestern side, from its junction with Parkwood Road for a distance of 30 metres northeast
- (ii) the southeastern side, from its junction with Parkwood Road for a distance of 13 metres northeast

HARVEY ROAD

SCHEDULE 2.03 : Waiting and loading/unloading prohibited at any time

- (i) both sides, from a point 6 metres south of the boundary of Nos. 3/5 to its junction with Parkwood Road
- (ii) the eastern side, from a point 6 metres south of the boundary of Nos. 9/11 to a point 3 metres north of the boundary of Nos. 5/7

SCHEDULE 2.27 : Waiting and loading/unloading prohibited Mon-Fri 8am-9.30am and 2pm-4pm

- (i) both sides, from a point 6 metres south of the boundary of Nos. 3/5 to a point 3 metres north of the boundary of Nos. 5/7
- (ii) the western side, from a point 6 metres south of the extended boundary of Nos. 3/5 to a point 77 metres south of the northern property boundary of No. 2

PARKWOOD ROAD

SCHEDULE 2.03 : Waiting and loading/unloading prohibited at any time

- (i) the northeastern side, from a point 15 metres northwest of the boundary of Nos. 30a/32 for a distance of 34 metres northwest
- (ii) the northeastern side, from a point 18 metres east of the centre line of Darracott Road for a distance of 64 metres northwest
- (iii) the southwestern side, from a point 15 metres northwest of the extended boundary of Nos. 30a/32 for a distance of 28 metres northwest
- (iv) the southwestern side, from the boundary of Nos. 25/27 for a distance of 33 metres northwest

SCHEDULE 2.27 : Waiting and loading/unloading prohibited Mon-Fri 8am-9.30am and 2pm-4pm

- (i) both sides, from the extended boundary of Nos. 25/27 to the eastern boundary of No. 37

SCHEDULE 3.17 : Waiting prohibited 8am-7pm

- (i) the northeastern side, from its junction with Christchurch Road to the boundary of Nos. 24/26
- (ii) the southwestern side, from its junction with Christchurch Road to a point 43 metres northwest of the extended boundary of Nos. 30a/32
- (iii) the southwestern side, from a point 15 metres northwest of the extended boundary of Nos. 30a/32 to a point 16 metres west of the centre line of Beechwood Avenue

SCHEDULE 8.51 : Waiting limited to 5 minutes Mon-Fri 8am-9.30am and 2pm-4pm return prohibited within 15 minutes

- (i) the northeastern side, from the boundary of Nos. 24/26 for a distance of 15 metres southeast
