## THE POOLE (TRAFFIC MANAGEMENT) (ASHMORE AVENUE) (AMENDMENT NUMBER 95) ORDER 2011

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

#### A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order

i	Ashmore Avenue	east side	from its junction with Blandford Road	for a distance of 38 metres in a southerly direction

### B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order

i	Ashmore Avenue	east side	from its junction with Blandford Road	for a distance of 58 metres in a southerly direction

#### C. The following shall be added to Schedule No. 5.09 (No Waiting, Mon-Fri, 8am-6pm) to the Order

i	Ashmore Avenue	east side	from the common boundary of Nos. 7 for a distance of 80 metres in a southerly direction
			and 9 Ashmore Avenue

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
- 3. This Order shall come into operation on the Tenth Day of January of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Ashmore Avenue) (Amendment No. 95) Order 2011.
