THE POOLE (TRAFFIC MANAGEMENT) (COOKE ROAD) (AMENDMENT NUMBER 14) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

i.	Cooke Road	both sides	from a point 146 metres south-west of its junction with Winston Avenue	for a distance of 25 metres, measured along the centreline of the carriageway, in a south-westerly direction
ii	Cooke Road	both sides	from a point 60 metres north-east of its south-western extremity	
iii	Cooke Road	both sides	from its junction with Winston Avenue	for a distance of 15 metres in a south-westerly direction
iv	Cooke Road	north-west side	from a point 10 metres north-east of its junction with Cooke Road Cul-de-Sac (even Numbers 14-48)	

A. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i	Cooke Road Cul- de-Sac (even Nos. 14-48)	both sides	from its junction with Cooke Road	for a distance of 10 metres in a north-westerly direction
ii	Cooke Road Cul- de-Sac (even Nos. 14-48)	north-east side	from its north-western extremity	for a distance of 26 metres in a south-easterly direction

iii	Cooke Road Cul-	south-west	from its north-western extremity	to a point opposite the south-eastern boundary
	de-Sac (even	side		of Nos. 24 Cooke Road

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
