## THE POOLE (TRAFFIC MANAGEMENT) (SANDECOTES ROAD) (AMENDMENT NUMBER 18) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

## A. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Durlston Road	both sides	from its junction with Sandecotes Road	for a distance of 15 metres in a south-westerly direction
ii	Durlston Road	both sides	from its junction with Sandecotes Road	for a distance of 15 metres in a south-westerly direction
i	Durrant Road	both sides	from its junction with Sandecotes Road	for a distance of 15 metres in a westerly direction
i	Sandecotes	south-west	from a point 15 metres south-east	to a point 15 metres north-west of its junction with
	Road	side	of its junction with Durlston Road	Durlston Road
ii	Sandecotes Road	west side	from a point 15 metres south of its junction with Durrant Road	to a point 15 metres north of Durrant Road

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
- 3. This Order shall come into operation on the Thirty-First Day of July of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Sandecotes Road) (Amendment No. 18) Order 2012.
