**THE POOLE (TRAFFIC MANAGEMENT)
(WIMBORNE ROAD) (AMENDMENT NUMBER 34) ORDER 2010**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 32, 35, 35(A), 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

A. The following shall be deleted from Schedule No. 5.17 (No Waiting Mon-Sat 8am-10am) from the Order:

i.	Wimborne Road	east side	from a point 13 metres north of its junction with the access road to Poole High School	to a point 28 metres south of its junction with Heckford Road

B. The following shall be added to Schedule No. 8.22 (Waiting Limited to Two Hours Mon-Sat 10am-6pm No Waiting Mon-Sat 8am-10am) to the Order:

i.	Wimborne Road	south-east side	from the common boundary of Nos. 60 and 62 Wimborne Road	to the common boundary of Nos. 72 and 74 Wimborne Road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the First Day of March of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Wimborne Road) (Amendment No. 34) Order 2010
