THE POOLE (TRAFFIC MANAGEMENT)
(ALBERT ROAD) (AMENDMENT NUMBER 22) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i	Albert Road	north-west side	from opposite a point 2 metres south of its junction with Khyber Road	to a point 7 metres north-east of its junction with Spring Gardens

B. The following shall be deleted from Schedule No. 5.07 (No Waiting At Any Time, Monday-Saturday, 8am to 6pm) from the Order:

i	Albert Road	west side	from a point 2 metres north of its junction with Carlton Grove	to a point 2 metres south of its junction with Khyber Road

C. The following shall be deleted from Schedule No. 6.01 (No Loading or Unloading At Any Time) from the Order:

i	Albert Road	both sides	from its junction with Ashley Road	for a distance of 15 metres in a northerly direction

D. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Albert Road	west side	from a point 48 metres north-east of its junction with Carlton Grove	to a point 7 metres north-east of its junction with Spring Gardens

E. The following shall be added to Schedule No. 6.01 (No Loading or Unloading At Any Time) to the Order:

i	Albert Road	east side	from its junction with Ashley Road	for a distance of 86 metres in a north-easterly direction
ii	Albert Road	west side	from its junction with Ashley Road	to a point 2 metres north-east of its junction with Carlton Grove

F. The following shall be added to Schedule No. 6.03 (No Loading or Unloading At Any Time, Monday-Saturday, 8am - 6 pm)

i	Albert Road	west side	from a point 2 metres north-east of its junction with Carlton Grove	for a distance of 46 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Thirty-First Day of July of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Albert Road) (Amendment No. 22) Order 2012.
