

**BOROUGH OF POOLE  
THE POOLE (TRAFFIC MANAGEMENT)  
(DEVON ROAD) (AMENDMENT NUMBER 46) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 19, 32, 33, 35, 35A, 35B, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:**

i.	Devon Road	west side	from its northern extremity	for a distance of 10 metres in a southerly direction

**B. The following shall be deleted from Schedule No. 7.39 (On Street Parking Place Waiting Limited to Two Hours Mon-Fri 8am-6pm Except Permit Holders Only) from the Order:**

i	Devon Road	east side	from a point 28 metres south of its northern extremity	to the common boundary of Nos. 5 and 7 Devon Road
ii	Devon Road	west side	from a point 10 metres south of its northern extremity	to the common boundary of Nos. 5 and 7 Devon Road

**C. The following shall be added to Schedule No. 5.12 (No Waiting Mon-Fri 8am-10am and 2pm-4pm) to the Order:**

i	Devon Road	west side	from the common boundary of Nos 5 and 7 Devon Road	to its northern extremity
---	------------	-----------	--	---------------------------

**D. The following shall be added to Schedule 6.09 (No Loading or Unloading Mon-Fri 8am-10am and 2pm-4pm) to the Order:**

i	Devon Road	west side	from the common boundary of Nos. 5 and 7 Devon Road	to its northern extremity
---	------------	-----------	---	---------------------------

**E. The following shall be added to Schedule 7.39 (On Street Parking Place Mon-Fri 8am-6pm Permit Holders Only) to the Order:**

i	Devon Road	east side	from a point 28 metres south of its extremity	to a point opposite the common boundary of Nos. 5 and 7 Devon Road
---	------------	-----------	---	--

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Third Day of April of the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Devon Road) (Amendment No. 46) Order 2012
