

**BOROUGH OF POOLE
THE POOLE (TRAFFIC MANAGEMENT)
(OAKFIELD ROAD) (AMENDMENT NUMBER 67) ORDER 2013**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 3, 2(1), 2(2C), 2(4), 3(1), 3(2), 4(1), 4(2), 4(3), 5, 32, 33, 35, 35A, 35B, 35C, 36, 45, 46(A), 47, 49, 51, 52, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Oakfield Road	north-east side	from its junction with Stanley Green Road	for a distance of 15 metres in a south-easterly direction

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Oakfield Road	north-east side	from its junction with Stanley Green Road	for a distance of 10 metres in a south-easterly direction

C. The following shall be added to Schedule No. 6.09 (No Loading or Unloading, Mon-Fri, 8am-10am and 2pm-4pm) to the Order:

i	Oakfield Road	north-east side	from its junction with Stanley Green Road	for a distance of 10 metres in a south-easterly direction
ii	Oakfield Road	south-west side	from its junction with Stanley Green Road	for a distance of 22 metres in a south-easterly direction

iii	Stanley Green Road	south-east side	from a point 14 metres south-west of its junction with Oakfield Road	to a point 15 metres north-east of that junction
iv	Stanley Green Road	south-east side	from a point 14 metres south-west of its junction with Oakfield Road	to a point 15 metres north-east of that junction

D. The following shall be added to Schedule 7.14 (On-Street Parking Place Disabled Persons Parking Only) to the Order:

i	Oakfield Road	north-east side	from a point 10 metres of its junction with Stanley Green Road	for a distance of 6.6 metres in a south-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fifth Day of November the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Oakfield Road) (Amendment No. 67) Order 2013
