B. The following shall be deleted from Schedule No. 5.05 (No Waiting, 8am-6pm) from the Order:

ii	Wessex Road	both sides		to a point 14 metres west of its junction with Station Road/Approach Road

C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Wessex Road	north side	from its junction with Salterns Road for its total length
ii	Wessex Road	south side	from its junction with Station for a distance of 14 metres in a westerly direction

iii	Wessex Road	south side	from its junction with Salterns Road for a distance of 14 metres in an easterly direction
iv	Wessex Road	south side	from a point 14 metres of its junction to a point 14 metres east of that junction
			with Curzon Road
