The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 4(1), 4(2), 4(3), 5, 26, 28, 63A, 65, 66, 81, 82, 84(1) and (2), 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders made for the Regulation of Vehicle Movements and Speed Limits) Order No. 2 be amended as follows

## A. The following shall be added to Schedule No. 5.01 (20 MPH Speed Limit NEW) to the Order:

- 2. Save as hereby amended The Poole (Various Roads) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders Made for the Regulation of Traffic Movement and Speed Limits) Order No. 2 shall remain in full force and effect.
- 3. This Order shall come into operation on the Eleventh Day of February of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Station Approach/Moor Road/Wentworth Drive 20 MPH Zone) (Amendment No. 96) Order 2013.
