(AMENDMENT NUMBER 101) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66, 87 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 6.01 (No Loading or Unloading at Any Time) from the Order:

i	Lulworth Avenue	both sides	from the common boundary of Nos. 91 and 93 Lulworth Avenue	to the railway level crossing

B. The following shall be added to Schedule No. 6.01 (No Loading or Unloading Mon-Fri 8am-10am and 2pm-4pm) to the Order:

i.	Lulworth Avenue	north side	from the common boundary of Nos. 91 and 93 Lulworth Avenue	to the railway level crossing
ii	Lulworth Avenue	south side	from outside No. 90 Lulworth Avenue	to the railway level crossing

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fourth Day of March of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Lulworth Avenue) (Amendment No. 101) Order 2013.
