**THE POOLE (TRAFFIC MANAGEMENT)
(VANGUARD ROAD) (AMENDMENT NUMBER 45) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(c), 4(1), 4(2), 4(3), 5, 19, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Vanguard Road	north-east side	from its junction with Sterte Road kerb line	for a distance of 24 metres in a south-easterly direction

B. The following shall be deleted from Schedule No. 7.22 (Taxis Only) from the Order:

i	Vanguard Road	north-east side	stand for three hackney carriages commencing at a point 24 metres south-east of its junction with Sterte Road	for a distance of 15 metres in a south-westerly direction

C. The following shall be deleted from Schedule No. 9.03 (Bus Stop Clearway) from the Order:

i	Vanguard Road	south side	from a point 6 metres east from its junction with Holes Bay Road	for a distance of 13 metres in an easterly direction

D. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Vanguard Road	north-east side	from its junction with Sterte Road kerblines	for a distance of 38 metres in a south-easterly direction

E. The following shall be added to Schedule No. 7.14 (Disabled Persons Parking Only) to the Order:

i	Vanguard Road	south-west side	Vanguard Road	under Towngate Bridge, maximum stay 3 hours

F. The following shall be added to Schedule No. 7.22 (Taxis Only) to the Order:

i	Vanguard Road	south side	from a point 24 metres south-east of its junction with Sterte Road	for a distance of 15 metres in a south-westerly direction

G. The following shall be added to Schedule No. 8.06 (Waiting Limited to 30 Minutes, Mon-Sat, 8am-6pm) to the Order:

i	Vanguard Road	north side	from a point 17 metres of its junction with Holes Bay Road	for a distance of 7 metres in a south-easterly direction and for 15 metres in a northerly direction

H. The following shall be added to Schedule No. 9.03 (Bus Stop Clearway) to the Order:

i	Vanguard Road	north-east side	from a point 24 metres south-east of its junction with Sterte Road	for a distance of 15 metres in a south-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of April of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Vanguard Road) (Amendment No. 45) Order 2012.
