**(AMENDMENT NUMBER 99) ORDER 2013**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 2(4), 3(1), 3(2), 4(1), 4(2), 4(3), 5, 26, 28, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66, 81, 82, 84(1), (2), 85(1), (2), (4), (5), 87, 89, 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be added to Schedule No. 6.01 (No Loading or Unloading at Any Time) to the Order:**

i.	Jolliffe Avenue	both sides	from its junction with Jolliffe Road	for a distance of 20 metres in a south-easterly direction
i	Jolliffe Road	both sides	from a point 15 metres south-west of its junction with Marnhull Road	to a point 30 metres north-east of that junction
i	Marnhull Road	northern side	from its junction with Jolliffe Road	for a distance of 32 metres in a westerly direction
ii	Marnhull Road	south-west side	from its junction with Jolliffe Road	for a distance of 15 metres in a north-westerly direction

**B. The following shall be added to Schedule No. 6.09 (No Loading or Unloading Mon-Fri 8am-10am and 2pm-4pm) to the Order:**

i	Jolliffe Avenue	both sides	from a point 20 metres south of its junction with Jolliffe Road	to its south-eastern extremity

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
- 3. This Order shall come into operation on the Fourth Day of March of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Jolliffe Road/Jolliffe Avenue/Marnhull Road) (Amendment No. 99) Order 2013.
