**THE POOLE (TRAFFIC MANAGEMENT)
(CREEKMOOR LANE/BENMOOR ROAD) (AMENDMENT NUMBER 97) ORDER 2013**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Benmoor Road	both sides	from its junction with Creekmoor Lane	for a distance of 55 metres in a westerly direction

B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Benmoor Road	north side	from its junction with Creekmoor Lane	for a distance of 10 metres in a north-westerly direction
ii	Benmoor Road	south side	from its junction with Creekmoor Lane	for a distance of 55 metres in a south-westerly direction

C. The following shall be added to Schedule 6.01 (No Loading or Unloading at Any Time) to the Order:

i	Benmoor Road	both sides	from its junction with Creekmoor Lane	for a distance of 15 metres in a south-westerly direction
i	Creekmoor Lane	south-west side	from a point 8 metres north-west of its junction with Benmoor Road	to a point 8 metres south-east of that junction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Sixth Day of May of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Creekmoor Lane/Benmoor Road) (Amendment No. 97) Order 2013.
