## THE POOLE (TRAFFIC MANAGEMENT) (GORSE HILL ROAD) (AMENDMENT NUMBER 128) ORDER 2014

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

## A. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Gorse Hill Close	northern side	from its junction with Gorse Hill Road	for a distance of 8 metres in a north-westerly direction
ii	Gorse Hill Close	southern side	from its junction with Gorse Hill Road	for a distance of 8 metres in a south-westerly direction
i	Gorse Hill Crescent	northern side	from its junction with Gorse Hill Road	for a distance of 8 metres in a north-westerly direction
ii	Gorse Hill Crescent	southern side	from its junction with Gorse Hill Road	for a distance of 8 metres in a south-westerly direction
i	Gorse Hill Road	west side	from its junction with Gorse Hill Crescent	for a distance of 8 metres in a southerly direction
ii	Gorse Hill Road	west side	from its junction with Gorse Hill Crescent	for a distance of 8 metres in a northerly direction
iii	Gorse Hill Road	west side	from its junction with Gorse Hill Close	for a distance of 8 metres in a southerly direction
iv	Gorse Hill Road	west side	From its junction with Gorse Hill Close	for a distance of 8 metres in a northerly direction

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
- 3. This Order shall come into operation on the Twenty Second Day of August of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Gorse Hill Road) (Amendment No. 128) Order 2014.
