## THE POOLE (TRAFFIC MANAGEMENT) (GOOD ROAD) (AMENDMENT NUMBER 146) ORDER 2014

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

## A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Good Road	both sides	from its junction with Herbert Avenue	for a distance of 14 metres in a south westerly
				direction

## B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Good Road	north side	from a point 51 metres south of its junction	for a distance of 32 metres in a north-westerly
			with Herbert Avenue	direction
ii	Good Road	north side	from its junction with Herbert Avenue	for a distance of 14 metres in a north-westerly direction
iii	Good Road	south side	from a point 15 metres south of its junction	for a distance of 50 metres in a south-westerly
			with Herbert Avenue	direction

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
- 3. This Order shall come into operation on the Seventeenth Day of February of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Good Road) (Amendment No. 146) Order 2014.
