

**THE POOLE (TRAFFIC MANAGEMENT)
(LOWER GOLF LINKS ROAD) (AMENDMENT NUMBER 144) ORDER 2014**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Lower Golf Links Road	south-west side	from a point 15 metres north-west of its junction with Moor Road	to a point 15 metres south-east of the said junction
ii	Lower Golf Links Road	both sides	from its junction with Dunyeats Road	for a distance of 15 metres in a northerly direction

i	Moor Road	north-west side	from opposite a point 22 metres north-east of its junction with Tudor Road	to a point 15 metres north-east of its junction with Golf Links Road

B. The following shall be deleted from Schedule No. 8.16 (On Street Parking Place Waiting Limited to Two Hours, Mon-Fri, 8am-6pm) from the Order:

i	Moor Road	north-west side	from opposite a point 17 metres north-east of its junction with Tudor Road	for a distance of 5 metres in a north-easterly direction
ii	Moor Road	north-west side	from a point 10 metres south-west of its junction with Golf Links Road	for a distance of 5 metres in a south-westerly direction

C. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i	Greensleeves Avenue	both sides	from its junction with Lower and Upper Golf Links Road	for a distance of 15 metres in a northerly direction

i	Lower Golf Links Road	east side	from its junction with Dunyeats Road	for a distance of 22 metres in a northerly direction
ii	Lower Golf Links Road	south-west side	from a point 25 metres north-west of its junction with Moor Road	to a point 15 metres south-east of the said junction
iii	Lower Golf Links Road	west side	from its junction with Dunyeats Road	for a distance of 43 metres in a northerly direction

iv	Lower Golf Links Road	east side	from the eastern junction of Moor Road	for a distance of 15 metres in a north-westerly direction
v	Lower Golf Links Road	north side	from its junction with Greensleeves Avenue	for a distance of 15 metres in a north-westerly direction
vi	Lower Golf Links Road	east side	from the eastern junction with Moor Road	for a distance of 35 metres in a south-easterly direction

i	Moor Road	both sides	from its junction with Lower Golf Links Road	for a distance of 15 metres in a northerly direction

i	Upper Golf Links Road	north side	from its junction with Greensleeves Avenue	for a distance of 15 metres in a north-easterly direction

D. The following shall be added to Schedule No. 8.16 (Waiting Limited to Two Hours, Mon-Fri, 8am-6pm) to the Order:

i	Moor Road	north-east side	from a point 17 metres north-east of its junction with Tudor Road	for a distance of 24 metres in a north-easterly direction

E. The following shall be added to Schedule No. 8.28 (On-Street Parking Place, Mon-Fri, 8am-6pm, 2 Hours Only, No Return Within One Hour) to the Order:

i	Lower Golf Links Road	east side	from a point 22 metres of its junction with Dunyeats Road	for a distance of 72 metres in a north-westerly direction
ii	Lower Golf Links Road	east side	from a point 15 metres of the eastern junction with Moor Road	for a distance of 336 metres in a northerly direction
iii	Lower Golf Links Road	west side	from a point 43 metres of its junction with Dunyeats Road	for a distance of 137 metres in a north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Seventeenth Day of February of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Lower Golf Links Road) (Amendment No. 144) Order 2014.
