
The Council of the Borough of Bournemouth ("the Council"),

- in exercise of its powers under Sections 22 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 ("the Regulations") and of all other enabling powers; and
  - after consultation with the Chief Officer of Police,
- hereby makes the following Order:-

1. The Borough of Bournemouth (Parking Regulation Order) (Consolidation) Order 2001 is hereby varied by:
  - (a) the deletion from the Schedules thereto of the items contained in Schedule 1 to this Order, and
  - (b) the addition to the Schedules thereto of the items contained in Schedule 2 to this Order.
2. The Borough of Bournemouth (Parking Regulation Order) (Consolidation) Order 2001 as varied on divers dates and save expressly as varied aforesaid shall continue in full force and effect.
3. The provisions of Article 1 of this Order may be varied or amended within the regulations governing Experimental Orders. The persons authorised to agree such variations or amendments are: The Chief Constable of the Dorset Police and The Head of Planning and Transport of the Bournemouth Borough Council; or such of their officers as they may so authorise. Nothing in Article 1 of this Order shall apply to anything done upon the direction of or with the permission of a police constable in uniform or parking attendant.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. This Order shall come into operation on 24<sup>th</sup> June, 2005 and may be cited as THE BOROUGH OF BOURNEMOUTH (PARKING REGULATION ORDER) (EXPERIMENTAL) (LANSDOWNE ROAD) ORDER 2005.
