The Council of the Borough of Bournemouth ("the Council"),

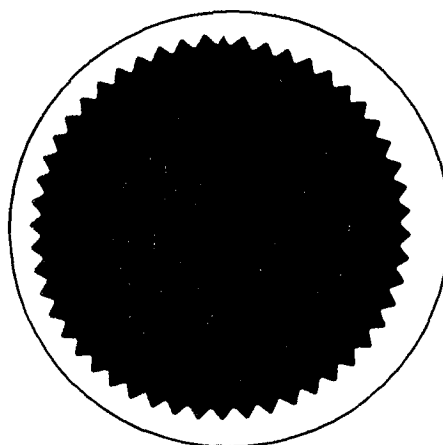
- in exercise of its powers under the Local Authorities' Traffic Orders(Procedure)(England and Wales) Regulations 1996 ("the regulation") and of all other enabling powers, and
  - after consultation with the Chief Officer of Police,
- hereby makes the following Order:-

1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 is hereby varied by;
  - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
  - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 22<sup>nd</sup> December, 2006 and may be cited as :

the southwestern side, from its junction with Stourfield Road south eastwards for a distance of 5 metres

the southwestern side, from its junction with Livingstone Road in a north-westerly direction for a distance of 14.6 metres east

the southwestern side, from its junction with Livingstone Road in a south-easterly direction to a point 8.6 metres northwest of the boundary of Nos. 143/147

- (i) the southwestern side, from the boundary of Nos. 61/63 for a distance of 59 metres in a north-westerly direction
- (iii) the southwestern side, from a point 2 metres southeast of its junction with Norwood Place in a south-easterly direction for a distance of 65 metres
- (v) the southwestern side, from the boundary of Nos. 67/69 for a distance of 24 metres in a south-easterly direction
