

**BOURNEMOUTH BOROUGH COUNCIL
(PARKING REGULATION ORDERS) (CONSOLIDATION) ORDER 2004
(VARIATION) (NO. 9) ORDER 2006**

The Council of the Borough of Bournemouth ("the Council"),

- in exercise of its powers under the Local Authorities' Traffic Orders(Procedure)(England and Wales) Regulations 1996 ("the regulation") and of all other enabling powers, and
 - after consultation with the Chief Officer of Police,
- hereby makes the following Order:-

1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 is hereby varied by;
 - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
 - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2004 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 20th August, 2007 and may be cited as :

SCHEDULE 201 : Waiting and loading/unloading prohibited at any time

- (i) the western side, from its junction with Avenue Road to the extended south-eastern boundary of Bourne Court

CHARMINSTER ROAD

SCHEDULE 201 : Waiting and loading/unloading prohibited at any time

- (i) the northwestern side, from its junction with Heron Court Road to a point 28.5 metres northeast of the centre line of Heron Court Road

SCHEDULE 315 : Waiting limited to 1 hour 8am-6pm return prohibited within 1 hour

- (i) the northwestern side, from a point 28.5 metres northeast of the extended centre line of Heron Court Road to a point 3 metres southwest of the north-eastern boundary of Nos. 139

WELLINGTON ROAD

SCHEDULE 101 : Waiting prohibited at any time

- (i) the northeastern side, from a point 37 metres northwest of its junction with Milton Road to a point 39 metres southeast of its junction with Milton Road
- (ii) the southwestern side, from its junction with Holdenhurst Road to its junction with Charminster Road

SCHEDULE 124 : Waiting prohibited Mon-Fri 8am-6pm

- (i) the northeastern side, from a point 79 metres north of its junction with Beechey Road to a point 39 metres southeast of its junction with Milton Road
- (ii) the northeastern side, from a point 8 metres northwest of the boundary of Nos. 63/65 to a point 37 metres northwest of its junction with Milton Road
