

**BOURNEMOUTH BOROUGH COUNCIL
(PARKING REGULATION ORDERS) (CONSOLIDATION) ORDER 2006
(VARIATION) (NO. 3) (PART 1) ORDER 2007**

The Council of the Borough of Bournemouth ("the Council"),

- in exercise of its powers under the Local Authorities' Traffic Orders(Procedure)(England and Wales) Regulations 1996 ("the regulation") and of all other enabling powers, and
 - after consultation with the Chief Officer of Police,
- hereby makes the following Order:-

1. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2006 is hereby varied by;
 - a) The deletion from the Schedules thereto of the items contained in Schedule 1 to this Order;
 - b) The addition to Schedules thereto of the items contained in Schedule 2 to this Order.
2. The Borough of Bournemouth (Parking Regulation Orders)(Consolidation) Order 2006 as varied on divers dates and save as expressly varied as aforesaid shall continue in full force and effect.
3. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. This Order shall come into operation on the 25th June, 2007 and may be cited as :

BROADWAY LANE

SCHEDULE 101 : Waiting prohibited at any time

- (i) the northwestern side, from the access road to Muscliff Primary School to a point 6 metres southwest of the boundary of Nos. 115/117

COPSEWOOD AVENUE

SCHEDULE 129 : Waiting prohibited Mon-Fri 10am-11am and 3pm-4pm

- (i) both sides, from its junction with Parkway Drive for a distance of 10 metres in a northerly direction

OVERSTRAND CAR PARK ACCESS ROAD

SCHEDULE 201 : Waiting and loading/unloading prohibited at any time

- (i) both sides, from its junction with Sea Road to the 'Honeycombe Beach' development boundary

PARKWAY DRIVE

SCHEDULE 129 : Waiting prohibited Mon-Fri 10am-11am and 3pm-4pm

- (i) the northern side, from its junction with Mount Pleasant Drive to the extended boundary of No. 55/57
- (ii) the southern side, from a point 4 metres west of the extended eastern boundary of No. 36 to the extended boundary of No. 55/57
